Dear Shri. Dhawan,

The issue pertains to shortfall in total applications received in the National Scholarships Portal (<https://scholarships.gov.in>) for the PM-USP Central Sector Scholarship for College and University Students (CSSS) for which the closing date is 31st December, 2022. From a recent analysis of the applications received so far it has been found that:

a) Number of applications from students who are getting admitted in the 1st year of college is substantial less than total scholarship slots available for your State, summarized below:

	Total	General	SC	ST	OBC
No. of Slots	113	58	17	8	30
No. of Applications up to 01 st Dec, 2022	61	32	3	2	24

b) In addition, nearly all applications received from the students are pending either at college level or at the State Level for verification. Unless the verification of application of both the levels are complete, further processing for scholarship cannot be done at the central level. A college-wise summary of applications pending for verification as on 1st December, 2022 is enclosed for ready reference.

2. In view of the above, kindly do the needful so that more students apply, and all applications are verified by the nodal officers at college and State level, which would benefit the poor and meritorious students desirous of pursuing higher education at your State.
