The fellowship is awarded to candidates selected for pursuing Ph.D/integrated M.Phil+Ph.D programmes.

National Fellowship Scheme for Higher Education of ST Students

This is a Central Sector Scheme fully funded and implemented by Central Govt for pursuing MPhil and PhD in following:

- Universities/Institutions/Colleges included under section 2(f) /12(B) or 2(D) and 12(B) of UGC Act
- Deemed to be Universities included under Section 3 of the UGC Act, 1956 and eligible to receive grants-in-aid from UGC.
- Universities/ Institutions/ Colleges funded by Central/ State Government.
- Institutes of National Importance.

Salient Features of Scheme

- Scholarship is provided to 750 fresh ST students every year each year for pursuing M Phil and PhD selected on merit based on marks of Master Degree.
- Preference is given to girls, Divyangans and PVTGs.
- The Scholarship is given for entire duration of the course pursued by the student.
- Fellowship for M.Phil is provided @ Rs. 25000/- per month and for Ph.D @ Rs.28000/- per month.
- Contingency and HRA Allowance is also given to fellows as per guidelines.
- The students have to apply on <https://fellowship.tribal.gov.in> for availing the scholarship.
