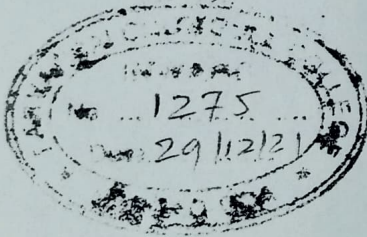

NOTIFICATION

In accordance with the Goa University Special Ordinance OS-1 relating to the conduct of Academic Programmes during COVID-19 Pandemic, it has been decided to exclude the period under which the Special Ordinance OS-1 is in force for counting the prescribed duration for completing the Programme.

Accordingly, Students who are completing Double the Duration during the Academic Year 2020-2021 shall be given the benefit and permitted to answer their examinations/keep terms during the Academic Year 2021-2022 or until Ordinance OS-1 is withdrawn whichever is later.


Further with reference to the Circular (Ref No. GU/Academic(Colg)/2020/21 dated 02-08-2020), the College shall grant a one time and final opportunity to candidates having backlogs to appear for examination and complete the Under Graduate Programme, beyond double the duration subject to the following conditions:

1. This one time opportunity would be allowed only for the existing/current Programme/Course being conducted by College, in view of the availability of syllabus, paper setters and teaching faculty who are conversant with the subject.
2. Candidates who have completed all the requirements of the course but could not obtain a degree due to failure in Semester End Examinations of theory papers alone.
3. This is a facility to clear backlog papers which prevented a candidate from obtaining his/her final degree.
4. Only those candidates who have completed/kept the terms and are otherwise eligible to appear for exam but could not appear due to "double the duration rule", will be allowed to appear.

5. Candidates will be allowed to appear irrespective of number of subjects/backlogs subject to point 2 and 3 above.
6. The candidates will be allowed to answer the papers/examination in one single sitting only, although this will be offered in two consecutive semesters.
7. All Continuous Assessment marks earned by the candidate shall be compulsorily considered.
8. Concerned students are required to fill the examination form on 13/01/2022(Thursday) or 14/01/2022(Friday) between 10am and 12noon only.
9. Payment of fees shall be done only after the approval by the Controller of Examinations.
