1 Career Advancement of Teaching Staff.	 Dr. Ananya Das inquired on whether evidential proofs of previous years prior to the year 2013-14 (when rule to maintain evidential proofs of their work conducted was implemented); may not have been maintained by the faculties as maintaining such records for such a purpose was not mandatory hence she requested whether such cases of those years could be waived off and thereafter rules on emphasizing of the evidential proofs should be made mandatory and make this knowledge known to all faculties also allowing them to prepare and collect their documentation proofs properly hereafter. Shri H. S. S. Nadkarni and Mr. V. C. Kumaresh suggested such years could be waived but certain mandatory evidential proofs would be necessary. e.g. Refresher courses, orientation courses. It was noticed while verifying file of a faculty that UGC guidelines for self appraisal differ with the point system with UGC guidelines under career advancement where the faculty has given points according to point system under guidelines for self appraisal is on yearly basis hence point system is drafted accordingly. Dr. Gunaji Desai inquired on whether to consider UGTAG membership as a professional body and give points for the same? – Dr. Ananya Das informed that UGTAG is not a professional body but it's an association. Dr. E.M.Travassos informed that professional membership is one in which the faculty being member of professional membership.

	 Dr. Gunaji Desai inquired how being a member of an committee under college (e.g. examination committee) can be justified? - As only specific faculties are chosen directly under committees whereas other faculties don't get suc opportunities at all. – Dr. Ananya Das suggested in suc cases every year new faculty should be given an opportunity to be part of the committee/s allowing them also to achieve those points under that category. Mr. V.C.Kumaresh suggested to have uniformity in all criteria's of the guidelines within the panel of committee members in order to have transparency and impartial judgments decisions.
