1. Chairman's Welcome

Chairman of the Academic Council, Dr. N. N. Sawant, welcomed all the members present and thanked them for giving their time and taking the trouble to attend the Academic Council Meeting.

2. Briefing on the Minutes of the Second Meeting of the Academic Council

The Chairman briefly went through the minutes of the previous Academic Council meeting held on 6^{th} February 2015 as the same were circulated to all the members earlier. The same were unanimously approved and passed.

3. Approval of the Proposed Grading System and the proposal for Academic Audit

Dr. Ananya Das made a presentation on the proposed Grading System as well as on the proposal for Academic Audit. Following the discussions, the Academic Council made the following recommendations related to the Academic Audit: (a) There should be no student representative on the Academic Audit Committee, (b) Academic Audit should be conducted Semester-wise, (c) Minimum quorum for the Academic Audit Committee Meeting should be defined, and (d) Constitution of Academic Audit Committee should be as follows:

- a. Chairman (To be nominated by Principal)
- b. Two subject experts (Nominated from the panel of Experts approved by the respective Board of Studies.)
- c. Member Secretary (nominated by the Chairman)
- **3.1 Resolution**: The Academic Council unanimously passed the resolution to approve the proposed Grading System and also the proposal for Academic Audit after incorporating the suggestions listed above.

4. <u>Presentation of the Draft Policies pertaining to Credits for Non-Evaluative (extra-curricular subjects/activities and internship) Component of the Undergraduate Courses</u>

Dr. E. M. Travassos, Member Secretary, presented the draft policies on the requirements for obtaining a total of Ten Credits for the two non-evaluated components of the Undergraduate Programmes, i.e. Six Credits for Extra-curricular Subjects/Activities and Four Credits for Internship.

Following the presentation, the Academic Council made the following suggestions: (a) All extra-curricular subjects should be listed and should also include subjects related to life-skills development, (b) Students should be allowed to take either one subject or a combination of two or three subjects as listed, (c) Complete a minimum of 60 contact hours in a subject to earn every two credits or a total of 180 contact hours, spread over the six semester period, in order to obtain six credits, (c) Students should complete the non-evaluated component of the undergraduate programme, preferably, by the end of the fourth semester.

4.1 <u>Resolution</u>: After incorporating the above recommendations, the Policies pertaining to Credits for Non-Evaluative (extra-curricular subjects/activities and internship) Component of the Undergraduate Courses were unanimously approved and passed

5. Report on the initiatives of the College under Autonomy

The Chairman Dr. N. N. Sawant, gave a presentation of initiatives taken by the College to popularize its autonomous status and to develop good practices under autonomy. He briefed the house about the marketing efforts and the orientation programs conducted before the beginning of the academic year for staff, students and parents regarding Autonomy.

The Academic Council suggested that information on any new policy / new program that is introduced or proposed to be introduced should be put online and online feedback obtained from all stakeholders, i.e. students, parents, and faculty, if possible.

6. Nomination of two experts for the Board of Studies in Portuguese

The Academic Council has nominated the following subject-experts to the Board of Studies in Portuguese of the Parvatibai Chowgule College of Arts and Science (Autonomous):

- a) Ms. Scarlet Fernandes, Assistant Professor, Dept.of Portuguese, Goa University
- b) Mr. Dhruv Usgaonkar, Assistant Professor, Dept.of Portuguese, Goa University

7. Approval of the proposed syllabi of various courses and syllabi of Under Graduate and Postgraduate Degrees

Syllabi of Under Graduate Degree Programs (B.A. and B.Sc) and Post Graduate Degree Program (M.A. in Hindi), approved by the respected Boards of Studies, were presented to the Academic council by the Chairmen of those Board of Studies.
