Additional suggestions made by the Academic Council:

1. For Biotechnology subject, the Academic Council suggested to give the students a project on 'How to increase the expiry date of products with short shelf life without adding preservatives'.

2. Mr. Kishore Shah suggested that:
 - a. College should liaison with the organizers of Serendipity – 2019 to showcase 'Chowgule College Pavilion' with focus on art related to Goa/Contemporary art.
 - b. Also, students should not be limited to do only voluntary work at such festivals but rather engage more productively for learning, exploring career opportunities.
 - c. Faculty should engage themselves in various events held in Goa.
 - d. Students from the department of English should participate at Goa Art Literary Festival (GALF).
 - e. For the Interdisciplinary course 'Philosophy of Existentialism in Literature and Films', suggestions were made to tie up with ISABs, Sumedhas etc for offering T-Labs for Industry.
 - a. The in-charge of Department of Philosophy was asked to check out programme details of 'Difficult Dialogues – 2018' for students' participation.
3. Mr. Shirish Kotmire stressed on the need to address the attention span of students as nowadays students' attention span is short.

4. To approve the proposal for Special Examination under Autonomy.

The house passed unanimously, the addition of the following new section in the Academic ordinance:

Ordinance AO-4.3(h)

The College will conduct a Special Examination to provide an opportunity to any student who has completed the sixth semester but has failed to get at least the minimum P grade for passing, in any of the courses for which they have kept terms during Semester I to Semester VI, to improve the grade in that course. This examination will be conducted after the declaration of results of the regular examinations held at the end of the even semester.

5. To approve the Modus of Operation for Online Courses

The house passed the Autonomy Ordinances - AO-7, reproduced below, relating to the Adoption of Open Online Courses at the Three-Year Undergraduate Programmes in Arts and Science with minor suggestion which was incorporated on the spot.

AO-7: Adoption of Open Online Courses

AO-7.1 The College may adopt, under the various categories of elective courses, some open online courses listed by the UGC under its Massive Open Online Courses (MOOCs) programme and offered on the SWAYAM (Study Web of Active Learning by Young and Aspiring Minds) learning platform.

AO-7.2 Objectives of adopting the open online courses:

- i. To enrich its existing curriculum
- ii. To provide an opportunity to students to acquire expertise that is presently not offered by the academic departments of the College.
- iii. To make students self-learners.

AO-7.3 Boards of Studies in different subjects may identify the open online course offered under the SWAYAM platform for adoption by the Department as an additional option to existing electives. The rigour of the online courses shall be equivalent to the regular courses. There will be a faculty-in-charge for the course.

AO-7.4 The adopted open online courses will be learnt through the online mode offered by the course providers. Periodic contact sessions consisting of 2 hours per credit shall be conducted by the department offering the course.

AO-7.5 Students seeking enrollment for online course should have passed all courses opted, and earned at least a B+ grade in the previous semesters. A student can enroll for the open online courses totaling a maximum of eight credits during the entire six semester period of the undergraduate degree programme.

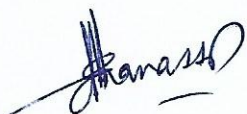
AO-7.6 The open online courses so adopted shall be evaluated as per the undergraduate evaluation policy and ordinances of the College.

6. Any Other Business (A.O.B.)

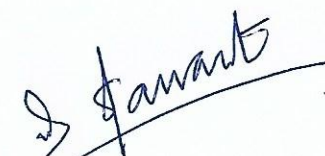
- a. The Academic Council unanimously approved the "Guidelines for the Evaluation of the Project work" with a suggestion that a template should be developed for rating each student in case of group projects.
- b. Dr. N. N. Sawant reported that the Chairman of the Governing Body had an interactive session with the Academic Council members nominated by the Governing Body and suggested to take a serious look on the following points:

- i. What would be the Skill enhancement on the courses provided by the department?
- ii. Reducing the quantum of syllabus for the students to enable them to work independently on their given tasks.
- iii. Reorganize each course from basic to more advance.
