
**PART B:** Important Points/ recommendations of BOS that require consideration / approval of Academic Council:

**New course “Introduction to Money and Banking” was introduced**

- VC nominee Dr. Aparna Lolayekar suggested an additional sub topic Central Banking: Functions and Overview in Unit 1.
- Alumni Ms. Swara Naik suggested Introduction of Bank’s Balance Sheet in the Unit 2.
- Academic council nominee Dr. Meenakshi Bawa suggested to change the title from “Monetary theory and policy” changed to “Monetary Policy”
- VC nominee Dr. Aparna Lolayekar suggested to include only central banking credit control measures in unit 3.
- Alumni Ms. Swara Naik suggested to include numerical techniques in unit 3.
- BOS members suggested to change the unit 4 title from “International Monetary Regimes” to “International Financial Institutions”
- Dr. Debasish Majumdar, chairperson suggested to include Asian development bank in unit 4.
- Alumni Ms. Swara Naik suggested to include Introduction to US FED Reserve system.
- All the BOS members approved the course outcomes and references.

**Revision of course syllabus “Indian Economy”**

- BOS members suggested mentioning the pre reform period i.e. from 1951-1991 in unit 1.
- Member Secretary Ms. Mahalaxmi Badiguir suggested to include brief introduction to the all five year plans in the unit 1.
- BOS members suggested changing the title of the unit 2 from key issues and challenges of Indian economy to key issues of Indian economy.
- BOS members suggested including all the modules as key issues.
