- 3. Any Other Business (A.O.B.)

#### **PART A:** Resolutions:

1. The syllabi of PG Courses of Semester III and Semester IV were presented and discussed in the meeting. After minor changes, the BOS resolved to pass the syllabi for the following undergraduate courses:

Resolved that the following major changes be made to **Writing for the Media** (**Technical Writing**) **PG-ENG-E-1 Semester III:** The nomenclature of the course to be changed to **Technical and Media Writing.** Usha Raman's reference book *Writing for the Media* to be added to the primary references. Units III and IV to be balanced in terms of number of topics. In Unit IV, the writing components are to be written first and the software used in brackets.
- 2. Resolved that the following changes be made to **Green Studies PG-ENG-E-2 Semester III:** Vandana Shiva's work is to be added to Unit IV. Raymond William's work on Ecology is to be added to the references. It was suggested to take a look at Religion and its influence on Ecology, as well as ensuring that the course was critically focused. It was suggested to take a relook at the case studies in Unit IV.
- 3. Resolved that the following changes be made to **Visual Literature PG-ENG-E-3 Semester III:** The nomenclature of the paper to be changed to **Visual Literature Perspectives**. Pramod Nayar's *The Indian Graphic Novel: Nation, History and Critique* is to be added to the references.
- 4. Resolved that the following changes be made to **Popular Literature PG-ENG-E-7 Semester III:** It was suggested to add Chetan Bhagat or Amish Tripathi under non-evaluated texts. It was suggested that Shobha De could added. Units were to have focusses added to them for example Social Issues or discussions like Canonical v/s Popular, Modernism v/s Post Modernism. Tony Bennet's *Popular Fiction* to be added to references.

- Resolved that the following changes be made to Shakespeare PG-ENG-E-8

   Semester III: Critical response to Shakespeare Marxist, Feminist, or post-colonial (any 2) to be added.
- 6. Resolved that the following changes be made to **Women's Literature PG-ENG-E-14 Semester IV:** Suzi Tharu's *Women's Writing in India* to be added to references. It was suggested to add Shashi Deshpande's *That Long Silence* to be added. It was suggested that works of Gayle Rubi, Eve Sedgewick, Judith Butler, and Kate Millet could be added as well.
