- 2- To change the text book for the Core Compulsory courses for all semesters from 'Panorama' level 1, 2 and 3 to 'Echo' level 1, 2 and 3 and to use the texts 'Saison' and 'Version Original' as reference books. This was suggested with a view to introduce a new approach towards teaching and learning the French language, to introduce the new changing trends in teaching methodology and to introduce the new French socio- cultural aspects.
- 3- To offer more choices of texts, for the course 'Study of selected elementary text in French', besides the text 'Candid', namely, 'L'avare' by Moliere, 'Gargantua' by Rabelais and 'Le Chateau de ma mère' by Marcel Pagnol. This was suggested in order to offer a wide choice of texts as to enable the students to select the texts as per their interest.
The BOS recommended that the students should be allowed to choose more than one text if they wish to do so.
- 4- To design the syllabus for the course 'Initiation to translation' and discuss the same at the next BOS meeting.

PART B: Important Points/ recommendations of BOS that require consideration / approval of Academic Council:


