Agenda Items:

- 1- To review the entire syllabus for the odd semesters.

- 3- To state the prerequisites for each course. (Not compulsory)
- 4- To change the term 'Learning Outcomes' to 'Course Outcomes', with a minimum of four Course Outcomes for each course.
