## PART A: Resolutions

1. The syllabi of the undergraduate courses of semester I and II were reviewed and discussed at the meeting. After minor changes, the BOS passed the resolution to approve the reviewed syllabi of semester I and II.

2. The BOS passed the resolution to replace the core papers- 'World Civilisations, Persia, India, Greece and Rome (Earliest times to 500 A.D.) - I' and 'World Civilisations: Egypt, Mesopotamia, China and Maya (Earliest times to 1500 A.D.) - II' with 'History of Ancient India' and 'History of India From Gupta Age to 1206 A.D.' respectively.
3. The BOS passed the resolution to introduce the elective paper 'Goan Heritage and Culture' as interdisciplinary paper. It also suggested to draft syllabus for the second interdisciplinary paper 'Issues in Goa's History since Liberation'

2. To approve the introduction of the elective paper 'Goan Heritage and Culture' as interdisciplinary paper.


