Agenda Items:

- To approve the substitution of the paper'Indian Art and Architecture upto 1757 A.D.' (HIS III.E-2) scheduled in semester III, with 'History of the Marathas' (HIS. IV. E-7) 2. scheduled in semester IV.
- To approve the replacement of the paper 'World History (500A.D. to 1400 A.D.)-1' (HIS III. E-4) with 'Socio-Economic History of Europe (c. 800 A.D.-1700).' 3.
- To approve the guidelines for question paper setting. 4.
- To choose two members for the Departmental Academic Audit Committee. 5.

- 2. The BOS passed the resolution to substitute the paper 'Indian Art and Architecture upto 1757 A.D.' with 'History of the Marathas.'
- 3. The BOS passed the resolution to replace the paper 'World History (500A.D. to 1400 A.D.)-I' with 'Socio-Economic History of Europe (c.800 A.D.- 1700).'
- 4. The Chairman read out the 'General Guidelines for Setting Question Papers' at the Semester End Assessment prepared by the Faculty of Social Sciences. BOS passed the resolution to approve the pattern of the question paper that provided for a question paper with five main questions carrying 12 marks each.
- 5. The BOS passed the resolution to recommend panel of History faculty consisting of Dr. Varsha Kamat and Dr. Usha Bhende to be included in the Departmental Academic Audit Committee.
