### **Assessment & Evaluation:**

### Unit I. Movie Review

Movie review: Students will have to watch two movies and do a comparative analysis and submit a report with reference to the following pointers given below:

Plot of the movie; description of the central characters; analysis of the characters and the movie from a psychological perspective; suggest psychological treatment if any; critical evaluation of the movie.

# Students would be given movie suggestions by the course teacher. Students need to take prior approval from the course teacher before choosing the movies.

### Unit II Case Formulation

Students are required to review one case and formulate the case discussion for the same. They have to submit a report using DSM Case formulation and psychodiagnostic formulation and engage in discussion with the class. Each student will be required to present one case.

### Unit III Case study analysis

Students will be provided with two case studies, out of which one would be by local mental health professionals (Special child case) and one would be a published case online (case with normal development or mild problem behavior). The students are expected to analyze the two cases and also make a comparative report. Students have to submit a consolidated report where in the focus would be on understanding the developmental differences between normal children and special children with respect to the following:

### **Assessment and Evaluation:**

#### Movie review:

- Students will have to watch two movies based on childhood disability or with reference to any special needs and present it in the class with reference to: Plot of the movie; description of the central characters; analysis of the characters and the movie from a psychological perspective; suggest psychological treatment if any; critical evaluation of the movie.
- Students will also have to compare the two movies based on the above points and submit a report of the same.

# Students would be given movie suggestions by the course teacher. Students need to take prior approval from the course teacher before choosing the movies.

### Case Formulation:

Students will be given one case (case pertaining to a childhood disability or special need) each to present in class and discuss with the others. Each student will be expected to submit a report on the case discussion using the DSM case formulation and psychodiagnostic formulation. Students will be examining how to approach a child, the problem behavior and treatment modality etc. in the case discussion.

### Case Study Analysis

Students will be provided with two case studies, out of which one would be provided by local mental health professionals (Special child case) and one would be a published case online (case with childhood disability/special needs). The students are expected to analyze the two cases and submit a consolidated report. The case study component will focus on children with special needs and planning interventions for enhancing their development in the following areas:
