Term: As per Statue SC-15.13.1 the Governing Body shall be reconstituted every three years except for the UGC nominee who shall have a term of five years.

Meeting: At least twice a year

Functions of Governing body

SC-15.13.2 Function of the Governing Body:

Subject to the existing provision in the bye-laws of respective Colleges and rules laid down by the state Government/Goa University, the Governing Body shall:

- (a) Guide the College while fulfilling the objectives for which the College has been granted Autonomous Status.
- (b) Institute scholarships, fellowship, studentships, medals, prizes and certificates on the recommendations of the Academic Council.
- (c) Approve New Programmes of study leading to degree and/or diplomas.
- (d) All recruitments of Teaching Faculty/Principal shall be made by the Governing Body/State Government as applicable in accordance with the policies laid down by the UGC and State Government from time to time.
- (e) To approve annual budget of the College before submitting the same to the UGC.
- (f) Perform such other functions and institute Committees, as may be necessary and deemed fit for the proper development of the College.
- (g) The Governing Body may refer any of the subjects within its purview to the relevant Committee/Body of the Autonomous College. The report of the Committee shall be considered by the Governing Body.
- (h) The member of the Governing body shall safeguard the interest of the Autonomous College and honour the resolutions.
