- The programme will receive financial support initially for a period of 3 years. Further continuation of support will be based on evaluation of the programme. After a period of 3 years, the colleges would be eligible for consideration of Star College status based on evaluation by the expert committee. Decision of expert committee will be final. DBT will measure progress by following parameters.
 - Substantial increase in proportion of 'hands on' experimental work by students.
 - Increased access of undergraduate students to laboratory and bioinformatics infrastructure
 - Improvement in access to life sciences related journals
 - · Summer schools
 - Percentage of students pursuing life science as a career
 - · Measure effectiveness on the basis of feedback from students, faculty
- 2. The department does not encourage starting of biotechnology teaching programme at undergraduate level. The programme should lay emphasis on strengthening biotechnology component in existing life sciences courses and practical training, industry exposure to students, upgradation of faculty skills by organizing training for faculty.
- 3. The grant for equipment provided by DBT will be used for purchase of minor equipment (cost not exceeding ₹ 1.00 lakh) routinely used for classroom teaching for students. F-204-zoo/1756, dated 22nd January 2020 is Rs. 2,91,500/- and has been approved at the total cost of Rs.2.49 Lakhs (Rupee Two Lakhs Forty Nine Thousand Only) excluding GST as per the meeting held on 19.03.2020 as in Budgetary Prescriptions of the above mentioned Management Plan, the amount coated in on the higher side but since the area of Bondla Wild Life Sanctuary is only limited to 8.0 square Kms.

You are hereby asked to complete the work of writing of Management plan and to submit within the time frame of six months period Subject to the following time line & details of work having agreed to in the meeting held with the officials of Forest Department and Goa Forest Dev Corporation.

1. Period for Development of Wildlife Management plan

- The collection of data in the field and submission of draft management plan of Bondla Wildlife Sanctuary after incorporation of the suggestion made by Goa forest department to be done - 5 month period.
- Submission of Final draft Management Plan of NWLS after incorporating suggestions made by Forest Department – 1 month period.
- 3. Above period will be counted from the day of issue of this work order.

II. Points to be considered to draft the Management Plan

1. The draft management Plan of Bondla Wildlife sanctuary, Goa shall be written as per the latest policy guidelines issued by the Ministry of Environment, Forest & Climate Change, GOI and the format prescribed in the "A Guide for planning Wildlife Management in Protected Areas and Managed Mandscape" By Vishwas B. Sawarkar, Wildlife Institute of India, No. 1887 (1988) 1888 (19

- Dehradun. This shall also be as per the latest format/guidelines issued by Wildlife Institute of India, Dehradun.
- The GIS and remote sensing tools will be used for prescribing habit types and vegetations. Relevant data shall be procured and used from Forest survey of India, Dehradun
- Management plan shall be a guiding tool for better management of natural, culture and social resource falling within the Sanctuary area.
- 4. The proposed plan shall be executed within a 10 years' time (i.e. from 2021-22 to 2031-32) and in uniformity in approach, realistic, maintain quality and site specific wildlife Conservation plan
- 5. The objectives of the plan is to be have an assessment of present status of Flora/ Fauna and habitat of major Wildlife species in the Protected Area as well as in its impact area, probable impact of Protected on the flora, fauna in the Protected Area and to formulate appropriate imitative measures to prevent degradation of habitat in and around the Protected Area.
- The plan shall address the Wildlife Conservation issues in the NWLS as well as the 1 Kms Buffer Zones around the Protected Area.
- 7. There must be detailed survey of the above area for the major floral and faunal status, water regime, drainage pattern, and Wildlife usage and interface conflicts in order to develop an appropriate management strategy in conserving the ecology while effectively utilising the natural resources.
- 8. The expert/consultant in panel should be an experienced wild lifers or experts with at least ten years of field of experience in wildlife management and environmentalists and should asses the area for probable degradation of the forest and habitats and check out mitigative strategies through discussion with the local villagers, other stake holders in the locality and forest staff. The existing land pattern and rural economic structure should be analysed against the probable changes.
- The report should specify the experts visit in the area and the methodology adopted in arriving at the facts and findings. The list of management interventions proposed and budget estimation should be enlisted for both protected area and buffer zone to be implemented by the Dy.CF.
- 10. The field based activities proposed in the plan should be shown with geoco-ordinates as far as practical and suitable maps should be annexed to show the location.
- 11. The cost schedule (Mandays) and Phasing of works should be worked out and shown appropriately. The cost norms approved by the government will be bench mark.

Background

This INTERREG project focuses on the knowledge, inventory, preservation and enhancement of cultural heritage in the Indian Ocean area. It is led by geographers from the University of Reunion Island, members of the OIES (Indian Ocean: Spaces and Societies) research unit, as well as literature researchers from the LCF (Research Laboratory on Creole and Francophone spaces) research unit.

The Program is research-action oriented. The scientific approach is therefore enhanced with an initial theoretical corpus, analytical fieldwork and concrete final applications, drawing up a structuring project.

Our approach is based on a twofold observation:

- a) Heritage is an essential social need;
- b) The evolution of the notion of heritage broadens and increases the potential for recognition of heritage objects.

In this context, in line with this call for projects, we wish to highlight accurately the links between local and more affinity and/or community-based cultural heritage and global heritage (such as UNESCO places) in the Indian Ocean area.

As the Indian Ocean has been for a very long time an area of passage and migration, this research will thus make it possible to refine knowledge on what constitutes heritage but also what is rejected as such, depending on whether one is confronted with the spaces of departure or the spaces of arrival. We will use a contrastive and comparative approach,

Geographical coherence and historical consistency

The fieldwork remains, in general, still rather little treated and yet it is very rich in lessons. It can be broken down as follows (PaTRIM-OI):

- Reunion Island and Mauritius, island areas, both members of the Indian Ocean Community (IOC);
- Tanzania and India, territories outside the IOC in the Great Indian Ocean, also chosen here as coastal States.

Historical coherence is understood through two major areas of origin of the migratory waves towards the islands of the south-western Indian Ocean, each associated with a major historical sequence: the slave trade and slavery (here with the coast of Tanzania as a reference area, although it was not the only one), and indentured labor or subcontracted work (the flagship area here being India, although here too the historical process cannot be only reduced to it).

Scientific actions and methods

Action 1: Inventory, choice and typology of objects and sites

The inventory of heritage objects will be carried out in an exhaustive manner in the various fields studied with regard to official international or national recognition (Unesco, Archeological Survey of India, Cities of Art and History...).

The identification of lesser known or unrecognized objects-places will be the subject of a choice based on conditions of comparability and according to a justified subjective selection (historical, scientific and spatial coherence...).

Action 2: Comparative and critical analysis of the stakes of cultural heritage sites

The analysis aims to put into perspective the dynamics of cross-patrimonialisation of emblematic cultural landscapes and to identify their different stakes: political, economic, identity and territorial.

Based on pre-identified case studies, the synthetic research will focus on:

- A common methodology for the different sites: interview guide, survey questionnaires, field surveys, collection of audio and/or video testimony,
- A synthetic restitution using the hypothetico-deductive approach

Action 3: Promotion of the Intangible Heritage of the Indian Ocean area

The analysis aims, starting with texts, speeches and objects-places related to the history of slavery and indentured labor, to popularize and make better known to the general public the wealth of intangible heritage resulting from fieldwork.

The approach will also propose to work on other intangible materials such as culinary or musical aspects and see the crossbreeding and transformations in the indian ocean area.


