

1.The funds have been sanctioned by GSWA, under the Grant-in-aid as per the approval accorded by Chairperson, GSWA.

2.The amount sanctioned is as per the project proposal submitted by Principal Investigator Dr. Shaiesh Morajkar, Assistant Professor, Department of Biotechnology, Parvatibai Chowgule College of Arts and Science, Margao Goa vide proposal no. F.42/339 dated: 23/06/2023 forwarded through proper channel to GSWA.

3.The expenditure incurred should be with the approvals from, and time to time requirements of the Principal Investigator - Dr. Shaiesh Morajkar, throughout the tenure of this project as stated in the proposal. The tenure of the project is 1 year from the date of date of issue of sanction order.

4. There should be a complete compilation of study conducted including reports, graphs, evidences of field work, documents, primary data, monthly progress report submission and ppt, secondary data and final copy the same shall be submitted to GSWA for office records.

5.The expenditure incurred should be in tune as per the terms laid down in the proposal submitted to GSWA.

6.There will no additional amount sanctioned above Rs. 3,75,240.00 to the proponent for this project.

7.The expenditures includes components such as field trips & surveys, travel for workshops, conference & meetings, stationary, purchase of gadgets & instruments as required for the proposed study.

8. The payment shall be made in the name of "Parvatibai Chowgule College of Arts and Science, Margao Goa", hence kindly submit the bank details urgently to the office of GSWA. The payment will be done in 04 instalments i.e.

- a. 30% as 01st installment released with sanction order
- b. 30% as 02nd installment released based on approval of the work done corresponding to the percentage of installment release i.e., 30% by the 'review committee',
- c. 30% as 03rd installment released based on the presentation of work done (same as above point (b)) and work required to be carried out to the GSWA Authority members and their subsequent approval
- d. 10% as 04th & final installment released based on the submission of the final project report to the GSWA Authority members and subject to their satisfaction for the same.

Any changes in the above pattern of release will be subject to approval of Chairperson, GSWA.

9. The project should start immediately from the date of issue of sanction order to Parvatibai Chowgule College of Arts and Science, Margao Goa.

10. The Principal Investigator of the project has to present/submit monthly progress report of the study to GSWA.

11. GSWA may abort or stop study if found unsatisfactory, any progress reports or due to any other reason which adversely affects the reputation of GSWA or ethics of research.

12. The Principal Investigator has to submit expenditure statement and utilisation certificate duly certified by the institution with final report copy at the end of the tenure of the project.
