agree to establish the following formal academic and cultural Memorandum Of Understanding (MOU) made as on May 3rd, 2016 and is signed and entered into between;

(Bromma and Chowgules are also referred to respectively as a "party" and the "parties" hereafter)

WHEREAS the parties seek to promote academic and cultural exchange and educational cooperation through academic and cultural exchange program between school-leaders, teachers and students of the two institutions.

THEREFORE, the parties agree to the following:

I. Program Dates and Goals

1. Student exchange will be on reciprocal basis. Chowgule and Bromma agree that both the parties will enroll a minimum of 8 students and a maximum of 15 students and minimum one and maximum four accompanying teachers/staff to participate in the exchange programe. The number of students enrolled may not be the same every year. Students from Bromma will be staying with the families of Chowgule students in Goa and students from Chowgule will be staying with the families of Bromma students on reciprocal basis in Stockholm.
2. The student exchange shall normally be for a period of 10 -14 days. This would be agreed between the parties every year.

3. The Bromma exchange group will normally be in Goa in November/December and Chowgule group will be in Stockholm in end Sept/beginning Oct the following year. This will be reviewed every year. Exception is the academic year 2016/2017 then Chowgule College visit Bromma during April instead of September.
4. The visiting institution shall notify the host institution of the names and other relevant information of the students/teachers/staff selected before the deadlines set by the host institution.

The expenses on account of stay and non-program meals of the accompanying teachers/staff of the visiting institution will be borne by the visiting institution. The host institution will assist the visiting institution in making arrangements for stay of the accompanying teachers/staff.
2. The host institution will accommodate students of the visiting institution in the homes of its students participating in the program.


3. Exchange students shall be responsible for contracting for their own health insurance in accordance with the policy of the host institution and immigration regulations. All exchange students are required to have health insurance valid in the host country.
4. The visiting institution will bear travel, visa and medical insurance costs of their participating exchange students and accompanying teachers/staff.

- considering that both institutions are called by the essence, goals and objectives, to establish communication channels, which would allow to exchange cultural and academic knowledge;

agree to establish the following formal cultural and academic Memorandum Of Understanding (MOU) made as on December 10, 2014 and is signed and entered into between;

(Tullinge and Chowgules are also referred to respectively as a "party" and the " parties" hereafter)

WHEREAS the parties seek to promote cultural and academic exchange and educational cooperation through academic and cultural exchange program between the students and teachers of the two institutions.

THEREFORE, the parties agree to the following:

I. Program Dates and Goals

1. Student exchange will be on reciprocal basis. Chowgule and Tullinge agree that both the parties will enroll a minimum of 6 students and a maximum of 15 students and minimum one and maximum four accompanying teachers/staff to participate in the exchange programme. The number of students enrolled may not be the same every year. Students from Tullinge will be staying with the families of Chowgule students in Goa and students from Chowgule will be staying with the families of Tullinge students on reciprocal basis in Stockholm.
2. The student exchange shall normally be for a period of 14 days. This would be agreed between the parties every year.
3. The Tullinge exchange group will normally be in Goa in November/December and Chowgule group will be in Stockholm in September. This will be reviewed every year.
4. The visiting institution shall notify the host institution of the names and other relevant information of the students/teachers/staff selected before the deadlines set by the host institution.



**CULTURAL AND SCIENTIFIC AGREEMENT
BETWEEN
THE UNIVERSITY OF PORTO
AND
PARVATIBAI CHOWGULE COLLEGE OF ARTS AND SCIENCE AUTONOMOUS**

The University of Porto, Porto, Portugal, represented by its Rector, Professor Sebastião Foyo de Azevedo, with official address at Praça Gomes Teixeira, 4099-002 Porto, Portugal, and

Parvatibai Chowgule College of Arts and Science Autonomous, represented by its Principal, Dr. Nandkumar N. Sawant, with official address at Gogol, Margao - Goa, 403602 India.

considering the importance of establishing cultural and scientific exchanges, which could contribute to the progress and encounter to different cultures;

considering that both institutions are bound with the same interests and objectives in the academic and cultural fields;

considering that universities are institutions called by the essence, goals and objectives, to establish communication channels, which would allow to exchange cultural and scientific knowledge;

agree to establish the following formal cultural and scientific agreement.

ARTICLE 1

The two institutions agree to the following objectives:

1. Increase the scientific and cultural relationship;
2. Further the development of mutual collaboration;
3. Exchange of information, materials and scientific information in those fields which are of interest to both institutions;
4. Promote teaching and researching in fields of mutual interest;
5. Promote the mobility of teachers, staff, researchers and students between both institutions;
6. Curriculum development;
7. Preparation of joint research projects;
8. Participation in seminars and academic meetings;
9. Exchange of accreditation procedures and standards.

ARTICLE 2

The two institutions agree to identify specific areas of collaboration and to design projects of academic collaboration that shall be determined by mutual accord in writing (addendums) and will not exceed the validity of the present agreement.

ARTICLE 3

Matters arising in relation to the implementation of the joint academic projects shall be negotiated and dealt with between the two institutions on a case-by-case basis.

All the expenses in executing the agreement will be negotiated and subject to the approval of the involved faculties, schools, institutes or departments of both institutions.

ARTICLE 4

The University of Porto appoints Prof. Maria de Fatima Aires Pereira Marinho Saraiva and Prof. Isabel Margarida Ribeiro de Oliveira Duarte, of the Faculty of Arts of the University of Porto, and Parvatibai Chowgule College of Arts and Science appoints Mr. Ashok Dinkar Dange and Ms. Sharmila Menezes, as Coordinators of the Projects of collaboration to be developed under this Addendum. Each Coordinator must present an annual activities report to the Rector of home Institution.

ARTICLE 5

The present agreement becomes effective on the date of its signature and is valid for the period of five (5) years after which it will be automatically terminated.

The agreement may be renewed upon mutual written consent by both institutions at least six (6) months prior to the date of termination.

ARTICLE 6

Any modification to the present agreement shall be undertaken by mutual decision in writing and any new changes will start on a date agreed by both institutions.

ARTICLE 7

Either institution may terminate this agreement by giving six (6) months' notice in writing. Termination of the agreement is subject to finalization of decided common projects and activities.

Fully accepting the articles stated above, the parties hereby sign this agreement in two (2) equally dated copies, in English language, with a copy to each part.

**ADDENDUM TO THE CULTURAL AND SCIENTIFIC AGREEMENT BETWEEN
THE UNIVERSITY OF PORTO
AND
PARVATIBAI CHOWGULE COLLEGE OF ARTS AND SCIENCE AUTONOMOUS**

The University of Porto (U.Porto), represented by its Rector, Professor Sebastião Foyo de Azevedo,

and

Parvatibai Chowgule College of Arts and Science Autonomous, represented by its Principal, Dr. Nandkumar N. Sawant,

agree to establish the present Addendum to the Cultural and Scientific Agreement signed on _____, which will be governed by the following articles:

ARTICLE 1

The present Addendum has as main goal to promote the academic, scientific, cultural and social relationships between the academic communities of both institutions.

Additionally, through this document partners seek to establish a student exchange programme (referred to below as Exchange Programme) under the common fields of study offered by each Institution. Such a programme aims at allowing the students, enrolled at the Institution of origin (Home HEI), to attend classes at the partner Institution (Host HEI), in order to accomplish part of the credits required by the Home Institution.

ARTICLE 2

1. Under the terms of the present Addendum, each Institution may select up to two (2) students per semester in each academic year (four (4) in total) to participate in the Exchange Programme. The number of students to be exchanged should be balanced during the term of this agreement.
2. Each Institution must inform the other about the necessary requirements to accomplish the Exchange Programme in the common fields of study, in particular the study plans and the classes/courses available for the exchange.
3. After the necessary analysis of the academic offer of the Host Institution, it is the responsibility of the Home Institution to propose the classes/courses that its students need to attend at the Host Institution.



4. The Home Institution is responsible for the selection of its applicants for the Exchange Programme based on academic excellence and in the serious interest in studying abroad.
5. The final acceptance shall be the sole responsibility of the Host Institution, according to its availability and ensuring the appropriate conditions for the exchange are met.
6. Each Institution must inform the other about the students selected for the exchange, providing information about their academic performance, as well as other information relevant to the success of the exchange.
7. The students that have already completed all the required credits to complete the degree at their Home Institution will no longer be eligible to participate in the exchange established under this Addendum.
8. The Home Institution is responsible for checking and ensuring that **at the time the students carry out the mobility, they are duly enrolled as regular students at the Home Institution** and that they still require classes/credits to finish their degree.
9. The Home Institution is responsible for proposing the length of the exchange, and this period must be of, at least, one academic semester, or, at the most, a full academic year.
10. The Home Institution shall provide all required information and documentation concerning the students proposed to participate in the Exchange Programme within the deadlines indicated by the Host Institution. Applications submitted after the established deadlines may result in the rejection of the student's application acceptance.
11. Each Institution shall send to the partner Institution information about the established deadlines for the application procedure.
12. The processes mentioned above shall be led by the International Cooperation Office (or equivalent) of the participant Institutions, by post or e-mail, as the case may be.

ARTICLE 3

1. Before initiating the exchange, students from both Institutions shall be bearers of a Learning Agreement approved by all the involved parties.
2. In case of need to change to the Learning Agreement, such changes must also be subject to approval by all parties.
3. The Host Institution is responsible for assigning the grades to the incoming students and to send the final certificate (Transcript of Records) to the Home Institution.
4. Upon the completion of the exchange, Host Institution must proceed with the validation/recognition of the classes/courses taken by the students at the Host Institution.
5. Under this Exchange Programme, the degree shall be obtained at the Home Institution. Students are not entitled to any academic recognition by the Host Institution.

ARTICLE 4

1. Students must be counselled and guided by both Home and Host Institutions before, during and after the exchange occurs.
2. Each student is responsible for the travel arrangements and incurred costs regarding their displacement for the exchange.
3. The students that participate in this Exchange Programme must register and pay the tuition fees and other financial costs at their Home Institution.
4. Students under this Exchange Programme shall be exempt from the payment of the tuition fees at the Host Institution, as long as it is ensured the reciprocity principle and kept the balance of students participating in this Exchange Program at each institution involved.
5. Each Host Institution will give support in finding accommodation for the Exchange students. The accommodation costs shall be covered by the participating students.
6. Both Institutions shall demand the students to subscribe a health insurance valid for the period of the Exchange Programme. The costs of such insurance shall be covered by the students.
7. Before leaving their country, the selected students shall ask for a study visa (if applicable) for the time of staying at the host country and at the Host Institution.
8. Student must be informed that they need to comply with all legal procedures in force at the host country, otherwise, they will not be authorized to participate in this Exchange Programme.

ARTICLE 5

1. At their Host Institutions selected students will benefit from the same rights and responsibilities that are in force for the institutions' own students.
2. The legislation and regulation in force at the Host Institution applies also to the exchange students.
3. Students may be subject to stipulated sanctions in case of non-compliance with the legislation and regulation in force.
4. The Home Institution shall be immediately informed (by e-mail) by the Host Institution in the event of any problem concerning its students.

ARTICLE 6

Under the present Addendum and upon its signature, the exchange of students may initiate as from the following semester, according to the academic calendar of the two Institutions and as long as the necessary conditions for the exchange are met.

ARTICLE 7

Under the present Addendum both Institutions may also promote the exchange of academic and administrative staff as well as researchers, aiming, predominantly, at the exchange of experiences

and the strengthening of the institutional links between the academic community of both institutions.

ARTICLE 8

Both universities are committed to finance this agreement to the best of their abilities with funding provided by the departments involved in the scientific exchange and also external sources.

ARTICLE 9

This Addendum shall be in force as from the date of its last signature until (same validity of the signed Cultural and Scientific Agreement), after which it will cease automatically.

This Addendum can be renewed by mutual consent, in writing, as long as the renewal of the Cultural and Scientific Agreement is ensured.

Either university may terminate this addendum by giving six (6) months' notice, in writing. Such termination shall not affect the completion of any ongoing activity at the time of the notice.



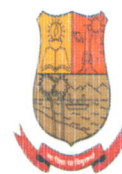

MEMORANDUM OF UNDERSTANDING (MOU)

a public institution of a scientific, cultural and professional nature,
situated at 15, Avenue René Cassin – CS 92003 – 97744 Saint-Denis Cedex 9 (La Réunion – France),
represented by its président, Professeur Frédéric MIRANVILLE,
Party of the First part

And

Parvatibai Chowgule College of Arts and Science (Autonomous)

a public institution of a scientific, cultural and professional nature,
situated at Gogol, Margao, Goa. Pincode : 403 602
represented by its Principal, Professor Nandakumar N Sawant,
acting in an official capacity by virtue of the powers conferred upon him,
Party of the Second Part,

Hereinafter jointly referred to as "the Partner Universities",

Driven by a common desire to establish and develop closer cooperation links in the fields of higher education and research,

Considering the legislative and regulatory provisions governing cooperation in the fields of higher education, scientific and technical research and culture, between the government of the French Republic and The Republic of India,

Agree upon the following provisions:

Article 1 – Cooperation

In compliance with the legislative and regulatory provisions in force in each of the institutions and in their respective countries, the Université de La Réunion and Parvatibai Chowgule College of Arts and Science (Autonomous) agree to foster the cooperations in the following fields:

1. 1. Exchanges of teaching and research staff
2. 2. Exchanges of students
3. 3. Exchanges of technical and administrative staff according to specific needs,
4. 4. Development of joint training programmes
5. 5. Development of joint research programmes
6. 6. Joint scientific supervision of research activities (joint supervision or direction of theses as appropriate)
7. 7. Facilitation of access to pedagogical and scientific knowledge (exchanges of documentation and publications)
8. 8. Joint organisation of colloquia, conferences, seminars and short training courses (summer courses)
9. 9. Participation in any type of exchange likely to promote their establishments and staff, whether in the framework of their internal operations or in the context of relationships with their economic, industrial, social or cultural environment
10. 10. Other forms of cooperation: new teaching products, e-learning, support for the implementation of new research structures, etc.

Article 2 – Scope of the agreement

The cooperation may concern any academic fields common to both partner universities.

On an annual basis, the universities shall exchange any information and any non-confidential documentation that will allow them to carry out the envisaged cooperation in addition to the exchange programme, where applicable.

Article 3 – Implementing conventions

The provisions relating to the activities provided for in articles 1 and 2 shall be jointly defined and shall be covered by specific implementing conventions according to the components and/or academic fields concerned.

These conventions shall specify the aims, contents, the staff involved and the pedagogical, administrative and financial procedures for the implementation of the bases of cooperation described in articles 1 and 2. These same additional agreements shall also mention the assessment and monitoring procedures and their frequency.

The implementing conventions may be updated on a regular basis as required. They shall be signed by the representatives of both partner universities.

Article 4 - Resources

The Parvatibai Chowgule College of Arts and Science (Autonomous) and the University of Reunion Island will try to foresee some of the means required for the carrying out of the present MoU and to obtain supplementary means.

Both parties understand that all the financial arrangements will have to be negotiated in advance and will depend on the availability of funds. They will give place to the establishment of a financial appendix and approved by the proper authorities of each of the institutes.

Article 5 – Exchanges of information - Confidentiality

Any information that is gathered or exchanged in the framework of the cooperation activity, including during scientific visits, in addition to the results of joint research or of jointly developed techniques, shall be confidential and cannot be disclosed to third parties without the prior, written authorisation of each of the partner universities.

The Parties undertake that any information exchanged in the framework of cooperation activities, which is identified as being confidential:

- a. a) Shall be kept strictly confidential and treated with the same level of protection that is afforded to their own confidential information
- b. b) Shall only be transmitted to members of staff that need to be aware of this information and shall only be used in application of the agreement, for a period of five years from the date of its transmission

Any other transmission or use of confidential information implies the prior consent of the Party that transmitted it Each Party undertakes that its staff referred to in b) above shall comply with

the provisions of the Convention

Notwithstanding the above-mentioned provisions, each Party may transmit confidential information that it can prove:

- To have been publicly available prior to its transmission or after it, but in the absence of any fault for which the Party can be deemed responsible
- To have been received from a third party in a lawful manner
- To have already been in its possession before entering into the agreement
- To have been developed independently and in good faith by members of its staff that did not have access to this confidential information.

Furthermore, these provisions cannot preclude:

- The obligation incumbent on each person participating in the cooperation to produce an activity report at his or her parent institution, insofar as this transmission of information does not constitute a disclosure as defined by the laws on industrial property
- The defence of a thesis relating to the subject of the cooperation; whenever necessary, this defence needs to be organised in such a way as to guarantee the confidentiality of certain results of work carried out in the framework of the agreement, while conforming to the university regulations in force.

Article 6 –Intellectual property

For each project involving cooperation in the research field, the partner universities must ensure effective protection and the equitable sharing of intellectual property rights.

The following rules shall apply to the cooperation:

- In the framework of research projects, each partner university shall remain the sole holder of any intellectual property rights acquired previously or resulting from independent research.
- Results concerning projects not covered by the previous paragraph, conducted in the scientific fields described in the implementing conventions that are appended to the agreement and likely to be protected on grounds of intellectual property, shall be afforded protection on the following bases: if a patent is filed, both partner universities shall jointly examine the procedures for filing, extending and maintaining the property rights according to the respective intellectual and financial contributions of the Parties.
- Each of the Parties undertakes to respect the other Party's intellectual property rights. Specifically, the intellectual property rights resulting from any research or collaborative activity in the framework of this Agreement shall be examined on a case-by-case basis, and shall be the subject of measures officially established by both partners.
- The Partner Universities must keep one another informed about any results of work authored or invented by members of the Partner University, which may be protected by Intellectual Property rights.
- The Partner Universities must conform to the confidentiality requirements defined pursuant to their respective national legislation and by national agreements, with particular attention to Article 39 of the World Trade Organisation's Agreement on Trade-Related Aspects of Property Rights (TRIPS).

Article 7 – Scientific publications and papers

The publications and scientific papers envisaged by the staff of research teams involved in the cooperation shall be produced under the responsibility of their Directors. The said projects for publications and papers shall be brought to their attention in sufficient time to allow them to contact the Parties' departments in charge of commercial exploitation so that they can implement any protective measures that may be required.

The authors' affiliations in the said publications and communications must follow the rules for scientific signature in force in each institution.

Article 8 – Duration of the agreement, modification, cancellation and renewal

This cooperation agreement shall enter into force from the date of the last signature written by either of the Parties, subject to the approval of the competent authorities of each country when this is required. It is entered into for a five-year period.

Each partner university may request the modification of the agreement. Such a modification shall be made by means of an amendment drawn up by mutual agreement of the Parties, subject to the approval of the competent authorities of each country when this is required.

Either of the partner universities may request the cancellation of the agreement, subject to notifying the other university of its decision in writing with six months' notice. In the event of cancellation, the actions in progress shall continue until the end of the current academic year, at the latest.

This agreement may be renewed for a maximum period of 5 years, after the submission of a renewal application by either of the two Parties, within a period of six months preceding the expiration date of the agreement. If necessary, each renewal must be approved by the competent supervisory authorities.

If this agreement is not renewed, the actions in progress shall continue until the end of the current academic year, at the latest.



Article 9 – Settlement of disputes

The partner universities shall endeavour to settle any disputes that may arise during the execution or performance of this agreement on an amicable basis.

Should an amicable solution not be possible, the dispute will be brought before the relevant court governed by the law of the insitute's country which seizes the justice to complain or lodge an appeal.

Article 10 – Text of the agreement

This agreement has been drawn up in four original copies of identical content, two of which are in the French language and two in the English language.


Kansai University and Parvatibai Chowgule College of Arts and Science Autonomous, agree to cooperate on international exchange programs.

This Agreement is to provide for the exchange of scholars, students, academic information and materials and others in the belief that the research and educational processes at our respective Institutions will be enhanced and that mutual understanding between our respective scholars and students will be increased by the establishment of such exchange programs.

- 1 Both the institutions agree to promote the following exchange programs, based on our respective academic and educational needs.
 - (1) Exchange of scholars (professors, lecturers or researchers)
 - (2) Exchange of students (undergraduate and graduate students)
 - (3) Exchange of academic information and materials
 - (4) Exchange of periodical academic publications
 - (5) Organization of joint research programs
 - (6) Organization of social and cultural programmes between the students and teachers of our two institutions
 - (7) Other academic exchanges to which both Institutions agree
- 2 The implementation of each exchange program based on this Agreement shall be separately negotiated and determined by both Institutions.
- 3 Such cooperative Agreements are not intended to be legally binding documents. They are meant to describe the nature and suggest the guidelines of such cooperation. Nothing, therefore, shall diminish the full autonomy of either Institution, nor will any constraints be imposed by either upon the other in carrying out the Agreement.
- 4 This Agreement shall be in force for five years, subject from time to time to revision or modification by mutual consent. This Agreement shall be renewed automatically if neither institution submits a desire in writing to terminate the Agreement with one year's prior notice.
- 5 This Agreement is written in the English language and two sets made; each institution shall retain one.
- 6 This Agreement shall become effective on the day when the representatives of both Institutions affix their signatures to the Agreement.



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") sets out the preliminary terms and conditions for developing an Industry-Academia relationship and to set forth the roles and responsibilities of each Party in connection with a potential strategic alliance ("Alliance Agreement" or "Agreement") relating to develop effective curricula, research targets and intellectual property around technologies for the Internet of Things and derivate applications. No agreement or contract, including this document, shall be deemed to be binding unless and until a final Alliance Agreement has been executed.

The Parties agree to proceed at their own risk and expense regarding the subject matter of this MOU until execution of an Agreement or termination of discussions, whichever occurs earlier. This document and the terms outlined herein are to be considered confidential.

A. Parties:

PARVATIBAI CHOWGULE COLLEGE OF ARTS & SCIENCE (hereinafter "PC College" or "the College") is a Margao, Goa (India) based educational institution that offers courses in the Bachelor of Arts, Bachelor of Science, Masters of Arts (Geography), Masters of Science (Information Technology) streams and post-graduate diploma in Computer Application and Biotechnology.

INFISWIFT, INC. is a State of California (USA) corporation having a principal office located at 12657 Alcosta Blvd, San Ramon, CA 94583 (hereinafter "INFISWIFT or Infiswift") that designs, develops, innovates and implements software, hardware, firmware and systems solutions for the world of connected, internet of things (IoT) devices.

Each of **PC COLLEGE** and **INFISWIFT** may be referred individually as “Party” and collectively as “Parties”.

B. Purposes:

The purposes of this MOU is to outline the terms by which the Parties intend to proceed to develop a preferred partnership whereby the Parties collectively enable the following (collectively, and with the other partnership arrangements described in this MOU, the “**Transaction**”):

1. PC COLLEGE has developed a long tradition and well-earned reputation for highly effective science education, especially in the fields of computer science and information technology. In this pursuit of academic excellence, the College continues to adopt innovative and ground breaking approaches to fostering industry alliances, providing practical experiences to its student body and staying at the cutting edge of relevant research.
2. INFISWIFT is an exciting entrant to the fast emerging world of IoT technology enablers. INFISWIFT’s platform is driving forward the cutting edge of innovations for the world of connected devices by creating new, highly efficient and massively scalable ways of interconnecting smart devices and systems.
3. PC COLLEGE and INFISWIFT intend to work together to study, research, prototype, demonstrate & develop the next generation of embedded technologies, data science methodologies and software innovations for the world of connected devices. This partnership will provide opportunity to the students and faculty of PC COLLEGE to engage in industry leading R&D with a commercial focus and highly marketable real-world experience, while developing a trained resource pool and intellectual property for INFISWIFT

C. Strategic Alliance:

The Parties desire to explore entering into an Alliance Agreement involving the following components of Strategic Alliance (the “**Alliance**”):

1. **Term:** The Parties intend that the initial term of any such Alliance will be 24 months and that the Alliance Agreement will include a mechanism for extension by mutual agreement as well as termination provisions customary for a transaction of this nature.
2. **Scope:** The Parties intend that the initial scope for collaborative

work will be for:

- a. Embedded systems including hardware, firmware, tools, libraries and sub-systems
- b. Data Science including algorithms, analytics and frameworks
- c. Software including cloud hosted and device hosted applications, pseudo and compiled code, libraries & tools
- d. Sensor, monitoring and detection technologies
- e. Networking and communications technologies
- f. Database, data storage and aggregation technologies
- g. And, systems, sub-systems, platforms, components and methodologies arising from and related to the above.

3. **Collaboration Milestones & Goals:** Under the alliance agreement, the parties intend to evaluate and implement where meaningful, the following:

- a. A guest speaker program for invited talks, seminars and workshops on relevant topics to be delivered on campus
- b. An undergraduate internship program. Ideally 120 hours or more in length and to be conducted both on campus and on site at Infiswift and affiliate offices
- c. An undergraduate IoT lab and corresponding program of study.
- d. Advisory roles on curriculum development committees
- e. Post Graduate Research Projects. Identify topics for focused 6 month projects
- f. Post Graduate Independent Study for advanced students and more complex subjects
- g. Technical Writing Course. Specify course module and advisory role on curriculum development
- h. Annual academia-industry technical symposium to be hosted on campus focusing on IoT and Internet of energy topics
- i. Any research publications raised out of the projects undertaken by the faculty/students of PC College will be preferably published by both the parties jointly.

4. **Roles of Each Party under the Alliance Agreement:**

- INFISWIFT to provide the following to the program and as needed on a project basis:
 - Access to industry thought leaders, subject matter experts and pioneers for talks, workshops, symposiums and events
 - Support for critical hardware, software, firmware and licenses to run a IoT lab
 - Access to qualified personnel to direct internships, research studies and projects
 - Access to qualified personnel to provide guidance and career mentoring and support for participating students
 - Insights and guidance on critical R&D areas, technical challenges and topics of study
 - Sponsorship and support as needed for events, gatherings and meetings emerging from this collaboration
 - Host select faculty and students for global industry leading events as relevant
 - PC COLLEGE to provide the following as needed on a project basis:
 - Access to faculty, undergraduate and post graduate students and related participants for the success of this collaboration
 - Access to campus facilities including auditoriums, meeting spaces, housing and exhibition areas to host events and meetings related to this collaboration
 - Use of labs, computers and other resources to students engaged in R&D, internships or projects emerging from this partnership
 - Marketing and brand presence for Infiswift in relevant events hosted by the college and the department of computer science that would benefit the goals of this partnership
 - Access to students, faculty, work products and facilities for Infiswift marketing needs that directly or indirectly promote this partnership
5. **Provision of Joint Program Administration:** INFISWIFT and PC COLLEGE will jointly define and staff a Program Administration group for purposes of developing the detailed collaboration plans. Parties will also work to develop co-marketing plans as part of their efforts to promote this relationship.
6. **Intellectual Property and Indemnification.** All emergent intellectual property will be the sole property of INFISWIFT

with retained, exclusive right to commercialize, patent, sell it in any form they may choose. To the fullest extent permitted by law, INFISWIFT will defend, indemnify, release, protect, and hold PC COLLEGE, its affiliates, subsidiaries, officers, agents, faculty and students harmless from and against any and all claims, damages, liabilities, losses, and expenses, including but not limited to attorneys' fees, arising out of or resulting, either directly or indirectly, from the following: (a) any action, claim, or allegations against PC College based, in whole or in part, upon a claim that the Services or any Deliverables, infringe a patent or a copyright, or violate a trade secret or any other intellectual property or proprietary right; (b) any action, claim or allegations that is based upon or alleges any negligent act, error, or omission or willful misconduct of INFISWIFT. INFISWIFT shall not be obligated to indemnify PC COLLEGE for damages caused by PC COLLEGE's sole negligence or willful misconduct.

D. Alliance Agreements:

Following the requisite internal approval of each Party, the Parties shall begin the preparation and negotiation of an Alliance agreement or agreements (the "**Alliance Agreement**") containing the terms of the Transaction based upon those set out herein, together with such other terms and conditions as are considered by the parties usual and reasonable for transactions of such nature. No binding arrangement with respect to such Transaction, or any part thereof, shall exist until a Alliance Agreement is fully executed with respect to such part or the whole of the Transaction, as applicable. The Parties shall use their commercially reasonable efforts to execute a Alliance Agreement by January 31, 2016.

E. Confidentiality:

The terms of this MOU, the Transaction, and all information supplied by any Party (or the affiliates, agents and consultants of such Party) in relation hereto shall be subject to the terms of the Mutual Nondisclosure Agreement executed between PC COLLEGE and INFISWIFT, dated December 15, 2015 (the "**NDA**").

F. Legal Effect:

Except as specifically set forth herein, this MOU constitutes a non-binding expression of interest among the Parties with respect to the matters contemplated herein, and is only intended to facilitate the preparation, negotiation and execution of any Alliance Agreement by the Parties, into which this MOU and all prior discussions and negotiations will merge. The Parties intend only to be bound by the terms of any Alliance Agreement entered and executed in writing by them, and neither Party shall have any obligation to proceed with the consummation of the transactions contemplated in this MOU. For the duration of the MOU, the Parties agree to cooperate as set forth in Section C.

G. Compliance with Laws:

The Alliance Agreement will include a provision substantially as follows: Each Party agrees to comply with the anti-bribery and books and records provisions of the Foreign Corrupt Practices Act ("FCPA"), the principles set out in the Organization for Economic Cooperation and Development Convention Combating Bribery of Foreign Public Officials in International Business Transactions ("OECD Convention"), and with all local laws prohibiting bribery and similar unethical business practices, and with the Party's own Foreign Anti-Corruption Policy Statement and Policy (in each case, "the Company's Policy"). Both Parties represent and warrant that, in connection with this transaction, such Party has not paid, offered, promised or authorized, directly or indirectly, a payment of anything of value in violation of the FCPA, the OECD Convention, local law, or the Company's Policy. Both Parties certify that said Party is not a foreign official (which includes being an officer, employee, or representative of any foreign government, department, state-owned, state-controlled, or state-operated entity, or a public international organization, of any political party, or being a foreign political candidate). A payment, offer, promise or authorization that is prohibited under this clause constitutes a material breach of this Agreement and the other Party may, in its sole discretion, terminate this Agreement immediately upon written notification to the breaching party.

H. Governing Law and Jurisdiction:

The Alliance Agreement will include a provision substantially as follows: This Agreement shall be governed by and construed and enforced in accordance with the laws of the *City of Geneva, Switzerland*, without giving effect to the conflict of laws principles thereof. Each of the parties hereby irrevocably consents and agrees that any claim, complaint, legal action or proceeding brought under this Agreement, shall be brought in courts of competent jurisdiction located in the City of Geneva, Switzerland and by execution and delivery of this Agreement each of the parties hereby (a) accepts the jurisdiction of the foregoing courts, (b) irrevocably agrees to be bound by any final judgment (after any appeal) of any such court, and (c) irrevocably waives, to the fullest extent permitted by law, any objection which it may now or hereafter have to the laying of venues of any suit, action or proceedings with respect hereto brought in any such court, and further irrevocably waives to the fullest extent permitted by law any claim that any such suit, action or proceedings brought in any such court has been brought in an inconvenient forum. Each of the parties agrees that a final judgment (after any appeal) in any such action or proceeding shall be conclusive and may be enforced in any other jurisdiction by suit on the judgment or in any other manner to the extent provided by law.

M. Miscellaneous:

The Alliance Agreement will include provisions substantially as follows, as well as other provisions customary for commercial agreements: No subsequent modification of the Agreement shall be binding upon the parties unless reduced to writing and signed by an

authorized representative of the party sought to be bound thereby.

In no event shall either party have any obligation or liability to the other nor shall any remedy be available to either party, except as expressly written herein. Limitations on liability, indemnities and releases set forth in the Agreement shall apply even in the event of fault, negligence or strict liability on the part of the party indemnified, released, or whose liability is limited, and extend to the parties' affiliates, employees, officers, directors and other related entities.

Neither party shall be liable to the other party for any indirect, incidental, special or consequential damages, however caused, whether as a consequence of the negligence, fault or conduct of the one party or otherwise.

Nothing in this Agreement shall preclude either party hereto from soliciting or accepting any contract from any third party under any other project.

Nothing in this Agreement is intended to create any partnership, joint venture, lease or equity relationship, expressly or by implication, between the Parties. Each Party shall bear all of its own expenses incurred in connection with its own activities and its activities under the Agreement. Neither Party has the authority to act for or on behalf of the other Party unless specifically agrees in writing.

N. Public Disclosure: The Alliance Agreement will include a provision substantially as follows: The Parties to this Agreement shall consult with each other as to the form, substance and timing of any press release or other public disclosure related to this Agreement or the transactions contemplated hereby, if any and no such press release or other public disclosure shall be made without the consent of the other Parties hereto; *provided, however*, that the Parties may make such disclosure to the extent permitted above or to the extent required by applicable law, including the requirements of the New York Stock Exchange or the United States Securities and Exchange Commission.

In consideration of the parties' discussions and any access of the Receiving Party to Proprietary Information of the Disclosing Party, the Receiving Party hereby agrees as follows:

1. The Receiving Party agrees (i) to hold the Disclosing Party's Proprietary Information in confidence and to take reasonable precautions to protect such Proprietary Information (including, without limitation, all precautions the Receiving Party employs with respect to its own confidential materials), (ii) not to divulge any such Proprietary Information or any information derived therefrom to any third person, (iii) not to make any use whatsoever at any time of such Proprietary Information except to evaluate internally its relationship with the Disclosing Party, (iv) not to copy or reverse engineer any such Proprietary Information and (v) not to export or re-export (within the meaning of U.S. or other export control laws or regulations) any such Proprietary Information or product thereof. If the receiving party is an organization, then the Receiving Party also agrees that, even within Receiving Party, Proprietary Information will be disseminated only to those employees, officers and directors with a clear and well-defined "need to know" for purposes of the business relationship between the parties. Without granting any right or license, the Disclosing Party agrees that the foregoing shall not apply with respect to any information after five years following the disclosure thereof or any information that the Receiving Party can document (i) is or becomes (through no improper action or inaction by the Receiving Party or any affiliate, agent, consultant or employee of the Receiving Party) generally available to the public, or (ii) was in its possession or known by it without restriction prior to receipt from the Disclosing Party, or (iii) was rightfully disclosed to it by a third party without restriction, or (iv) was independently developed without use of any Proprietary Information of the Disclosing Party. The Receiving Party may make disclosures required by law or court order provided the Receiving Party uses diligent reasonable efforts to limit disclosure and to obtain confidential treatment or a protective order and allows the Disclosing Party to participate in the proceeding.

2. Immediately upon a request by the Disclosing Party at any time, the Receiving Party will turn over to the Disclosing Party all Proprietary Information of the Disclosing Party and all documents or media containing any such Proprietary Information and any and all copies or extracts thereof. The Receiving Party understands that nothing herein (i) requires the disclosure of any Proprietary Information of the Disclosing Party or (ii) requires the Disclosing Party to proceed with any transaction or relationship.



This Agreement supersedes all prior discussions and writings and constitutes the entire agreement between the parties with respect to the subject matter hereof. The prevailing party in any action to enforce this Agreement shall be entitled to costs and attorneys' fees. No waiver or modification of this Agreement will be binding upon a party unless made in writing and signed by a duly authorized representative of such party and no failure or delay in enforcing any right will be deemed a waiver.





This MEMORANDUM OF UNDERSTANDING (hereinafter MOU) is made and entered into on this 16th of October, 2015 between Faculty of Humanities and Social Sciences, University of Sri Jayewardenepura, Sri Lanka (hereinafter FHSSUSJP), on the ONE PART and Parvatibai Chowgule College of Arts and Science, (Autonomous), Margao - Goa (hereinafter PCC), on the OTHER PART (who for the purpose of this MOU are hereinafter individually referred to as 'PARTY' and collectively referred to as the 'PARTIES').

The PARTIES, having discussed the fields of common research interests and allied activities between the two Universities, have decided to enter into a long-term collaboration in the areas of education, training and research.

WHEREAS University of Sri Jayewardenepura is an autonomous university established under the provisions of Universities Act No 16 of 1978 and it is the largest University in Sri Lanka in terms of student population. It is committed to the pursuit and transmission of knowledge through teaching, scholarship and research and active service to the community in an environment which values creativity, freedom of intellectual thought and expression, equal opportunity, fairness and professional growth.

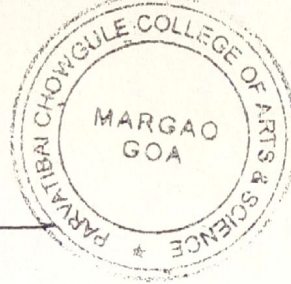





**ADDENDUM TO THE MEMORANDUM OF UNDERSTANDING BETWEEN
PARVATIBAI CHOWGULE COLLEGE OF ARTS AND SCIENCE
AND
WASEDA UNIVERSITY**

In order to further strengthen the cooperation between Parvatibai Chowgule College of Arts and Science, which is autonomous, and Waseda University we hereby agree to establish the following reciprocal student exchange program based upon principles of mutual benefit.

1. Each year, during the term of this Addendum, one institute may send up to one student, either undergraduate or graduate, to be enrolled at the other institute. It is understood that a balance in the number of students exchanged shall be sought over a five year period.

6. Exchange students shall pay whatever fees required of them by their home institute in order to participate in the programme and shall be exempt from paying tuition and academic fees to the host institute.
7. Each institute shall make every reasonable effort to assist exchange students in finding suitable accommodation. The payment of housing costs and payment for all travel, medical insurance and subsistence costs shall be the responsibility of the individual student participating in the programme and neither institute held liable for such charges. Students selected shall satisfy the home institute that they have adequate funds for transportation to and from the home institute and for subsistence during their stay.
8. Centre for International Exchange Programmes of Parvatibai Chowgule College of Arts and Science and the Center for International Education of Waseda University shall be the offices responsible for the administration of this student exchange programme.
9. This Addendum shall become effective on the date of signing for five years. It shall be renewed every five (5) years thereafter upon the mutual written consent of both parties. Either party may choose to terminate this Addendum by written notification to the other party. Termination will become effective six (6) months after the notification is received by the other party.

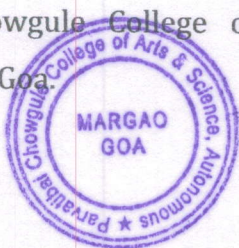

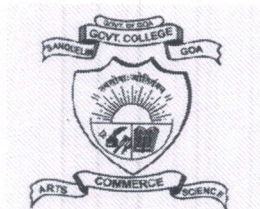

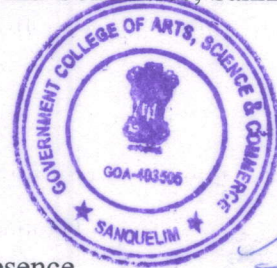

This Memorandum of Understanding is entered into by the Goa Institute of Public Administration and Rural Development, Ela Farm, Old Goa, Tiswadi-Goa and Parvatibai Chowgule College of Arts and Science, Margao-Goa are hereinafter referred to jointly as the 'Parties'.

The parties having discussed the field of common interests for training, research and allied activities between the two institutions, have decided to enter into a collaboration.

Whereas, GIPARD, earlier known as Goa Institute of Rural Development & Administration (GIRDA), is established under notification No. 10/1/2014 PER (Part) in the Official Gazette, Series I No. 15 dated 10/07/2014 is the State's apex autonomous training institute, catering to training, capacity building, research and consultancy activities. The major target audience being elected representatives, officials, functionaries of government departments, Non Government Organisations, Self Help Groups, academicians and students,

Whereas, Parvatibai Chowgule College of Arts and Science, Margao-Goa is a premier Institution in the State of Goa that provided higher education and is actively involved in research, training and consultancy. Recently it has been accredited by the National Assessment and Accreditation Council (NAAC) with a cumulative grade point average of 3.41 out of 4.00.

Whereas, there is a need for both parties to work jointly in order to efficiently achieve their goals through mutual sharing and cooperation and collaborate for mutual benefit.

Now, therefore the parties agree to as follows:

Article - I

- 1.1 The purpose of this MoU is to provide a framework of cooperation and facilitate collaboration between the parties to meet the broader goals of training and capacity building of government employees, Elected Representatives and civil society in the State. This collaboration would enable GIPARD to:
- 1.2 a) conduct number of training programmes thereby trying to achieve the targets as mandated in the State Training Policy of Goa.
- 1.3 b) to cater to the training programmes for the Elected Representatives at the block levels and district levels.

Article - II

- c. Budget for each programme will be prepared by GIPARD and allotted to the institute. 10% of the total programme cost towards institutional charges will be provided to the concerned institute. Funds will be released on a quarterly basis to the institute.
- d. The concerned institute will make the necessary arrangements for conducting the programme such as hall, seating arrangements, meals, refreshments, stationery, etc.
- e. The institute will submit bills, vouchers and refund the unutilised funds to GIPARD, within 15 days after the programme is over.
- f. The evaluation report and the report of the programme, group photo should be submitted along with the bills.

WHEREAS PCC is a premier institute in Goa involved in research, education and training in all the disciplines of Science and Arts, and reaccredited with Grade 'A' by NAAC. It was conferred Autonomous status in 2014. Ever since the inception of the college in year 1962 Psychology was offered as a subject under the department of Philosophy. As an independent department it came into existence in 2008. The department has grown in strength as also achievements with students securing ranks at the Goa University examinations, presenting and publishing papers in national and international conferences and journals as also participating and organizing intercollegiate events. In the year 2016, the Post Graduate course in Child Psychology & Child Development was established. Chowgule college has recently established the Teaching Learning Centre on 8th November, 2017.

MEMORANDUM OF UNDERSTANDING



Between

Vidya Prabodhini College of Commerce, Education, Computer and Management, Goa

And

Parvatibai Chowgule College of Arts And Science, (Autonomous), Margao, Goa

This MEMORANDUM OF UNDERSTANDING (hereinafter MOU) is made and entered into on this October, 2016 between Prabodhan Education Society's Vidya Prabodhini College of Commerce, Education, Computer and Management, Vidyanagar, Alto-Parvari-Goa (hereinafter VPCCECM), on the ONE PART and Parvatibai Chowgule College of Arts and Science, (Autonomous), Margao - Goa (hereinafter PCC), on the OTHER PART (who for the purpose of this MOU are hereinafter individually referred to as 'PARTY' and collectively referred to as the 'PARTIES').

The PARTIES, having discussed the fields of common research interests and allied activities between the two colleges, have decided to enter into a long-term collaboration in the areas of education, training research and development.

The Parvatibai Chowgule College of Arts and Science, Margao is a premier institution in the State of Goa that provides higher education and is actively involved in research, training and consultancy. Recently it has been accredited by the National Assessment and Accreditation Council (NAAC) with a cumulative grade point average of 3.41 out of 4.00, the highest for any College in Goa and the first to be Autonomous in Goa. It has a State of art infrastructure and an array of Student Support Services.

AND WHEREAS it has been considered expedient to agree in writing to participate jointly in undertaking students and faculty related assignments to enhance the quality of Colleges as per the expertise and logistics available with both the PARTIES

Article 1. OBJECTIVES

Article 3. CONSULTANCY AND EXTENSION ACTIVITIES

Article 4. EXCHANGE OF INFORMATION AND RESEARCH SAMPLES

4.1 The term "information sharing" includes scientific or technical data, tools, results and/or methods of investigation, and other information intended to be provided, exchanged or arising under the objectives identified under Article 3. The PARTIES shall take all measures to protect the secrecy of and avoid disclosure and unauthorized use of the information which is confidential and outside the public domain.

4.2 Knowledge exchanged between the PARTIES shall not be transferred to any third party for research and commercial purposes and that the unutilized portions of such samples must be sent back to the concerned coordinators.

Article 5. PUBLICATIONS AND INTELLECTUAL PROPERTY RIGHTS

5.1 Any research publications and intellectual property rights arising out of the students and joint research projects shall be jointly published and, when patented, will be jointly and equally owned by VPCCECM and PCC.

5.2 The procedural formalities for securing and maintaining the intellectual property rights shall be the responsibility of both VPCCECM/ PCC and the expenditure incurred thereof shall be borne jointly and equally by VPCCECM and PCC.

5.3 The upfront fee and royalty accrued from licensing of any intellectual property arising from this collaboration to other PARTY (IES) shall be shared between the PARTIES, the terms and conditions of which shall be the subject matter of a separate agreement between the PARTIES.

5.4 The PARTIES shall not assign any rights and obligations to any third PARTIES without consent of the other party.

Article 6. IMPLEMENTATION

6.1 The PARTIES agree to constitute an Advisory Committee as follows:

6.2 The Advisory Committee shall meet at least twice in a year either at VPCCECM or PCC to review the progress and planning for the new collaborative activities

6.3 Based on the education, training and research requirements of students and staff, the advisory committee shall, in consultation with the faculty and scientists, decide on topics and the mode of cooperation for each of the academic years during the tenure of this cooperation.

6.4 The convener and co-convener shall be the contact persons for all the cooperation and other related issues identified in this understanding.

Article 7. FINANCE

7.1 Each PARTY shall bear the respective costs of carrying out the obligations under this agreement. Neither PARTY shall make a claim against the other PARTY for any expenditure unless such expenditure has been agreed upon in writing between the PARTIES.

Article 8. GENERAL PROVISIONS

8.1 Research instrumentation, infrastructure and library facilities available at the PARTIES work place(s) shall be made available to the teaching faculty, research scholars and students of the PARTIES.

8.2 The PARTIES shall not use any of the confidential information which is required to be held in confidence for any purpose other than performance of their obligations under this understanding.

8.3 The implementation of the areas and forms of cooperation identified under Articles 2 and 3 shall be subject to the availability and convenience of research students, faculties and infrastructure facilities available at the PARTIES work places.

8.4 The PARTY organizing an item of work shall have the nodal responsibility for mobilizing resources and the conduct of such works.

- 8.5 There shall be exchange visits by faculty members for academic and research purposes.
- 8.6 There shall be exchanges of students between both the parties with the convenience of both the parties so that students can be benefitted by the good teachers of both parties.
- 8.7 All questions related to this understanding arising during its term shall be settled by the PARTIES by mutual agreement. The disagreements at the operating level shall be forwarded to the respective higher officials for appropriate resolution failing which an arbitrator of mutual acceptance may be identified.
- 8.8 Nothing in this understanding is intended to affect other cooperation or collaboration between the PARTIES.
- 8.9 All the collaboration activities pursuant to this agreement shall be conducted in accordance with the laws and regulations governing VPCCECM and PCC.
- 8.10 Both the PARTIES will discuss the finances, resources shared based on the project protocols and other formalities.

Article 9. ENTRY INTO EFFECT AND TERMINATION

- 9.1 This MOU shall become effective on the date it is signed by the PARTIES and shall be valid for three years. This understanding may be amended by mutual written agreement and may be terminated at any time by either PARTY upon one month's written notice to the other PARTY.
- 9.2 All joint activities not completed at the expiration or termination of this agreement may be continued until their completion under the terms of this understanding.

Article 10. AMENDMENTS

10.1 This MOU represents the entire understanding between the PARTIES and supersedes any and all understandings either oral or written hitherto with respect to the subject matter of this understanding.

10.2 No amendment or modification of the MOU shall be valid unless the same is made in writing by both the PARTIES and specifically stating the same to be an amendment of the MOU. The modifications/changes shall become part of the MOU and shall be effective from the date on which they are made/ executed unless otherwise agreed to.

Article 11. ASSIGNMENT

11.1 This MOU is based on the professional competence and expertise of each PARTY and hence neither PARTY shall transfer or assign this agreement or rights or obligations arising hereunder, either wholly or in part, to any third party.


Article 12. NON-EXCLUSIVITY

12.1 The relationship of the PARTIES under this understanding shall be non-exclusive and both PARTIES are free to pursue other agreements or collaborations of any kind. However, when entering into a particular education, training and research agreement, the participants may agree to limit each PARTY's right to collaborate with others on that subject.






