



We would like to inform you that while imparting education to the students, the College has to take into consideration various dimensions like Students' overall development including Intellectual development, Career building, physical fitness etc. for which the College has to be equipped with suitable infrastructure like Advanced Laboratory, Library, Conference Hall, Auditorium, Gym, Playground, Canteen etc. and also maintain the same. Considering the same, the College has created the best of such infrastructure and facilities.

The fees charged as Library Fee, Student Aid Fund, Lab practical Fee, Gymkhana Fee and other Fee are as per the University Notification and permissible Government guidelines for various facilities provided to the students.

The fees charged one time each year as Student Service Charges are for the regular maintenance of the additional infrastructure and facilities which the College provides and for which reason you have probably opted to join this particular institution. It is expected that every student of the college uses this infrastructure and facility for their personal growth.

As regards your concern about the sitting place at Library, there is a reading room, reference room and Computer lab available for students. The college encourages the students to use this facility. As regards Student Aid Fund, Students aid fund pertains to scholarship given to students. Students have to apply for it and there is a committee which decides who is eligible to get the scholarship amount. This fund is not for First Aid facility. Nevertheless, First aid box is readily available in the fitness centre and Physio centre.

As regards the other complaints, we wish to inform you that the College has provided purified drinking facility. Proper hygiene is maintained in canteen and surrounding area. The College has noted that taps and doors in the toilet as well as some of the ACs and Fans need maintenance and College will take immediate maintenance of the same.

SUBJECT: DETAILS OF THE FEE PAID BY US

Respected sir,

We the students of SYBSC would like to draw your attention that even after paying such huge amount we are not getting the facilities which we deserve and we would also like to know what are the things included under students service charge, gymkhana fee, other fees.

- Student service charge Rs.11500/-: Though it is mentioned in the receipt as the student service charges there are no proper specifications mentioned under it as in what are the facilities provided under this particular charges. We would like to known what services are been given under above mentioned amount.
- 2. Library fee Rs.470/- (chemistry, physics, zoology, geology, maths,computer science) Rs.1000/- (Biochemistry, Biotechnology): As we all know library is a place where we have to sit and read book quietly but we don't seems to see any proper place where we can sit and refer to the book or do our studies if we want to do so. There is a computer lab which was open last year for students but this year it has been closed from the beginning of this academic year. So we would like to know if we don't have a proper place to sit and refer the books what is the use of taking them home since at home we can get those pdfs easily through google.
- 3. Students aid fund Rs.130/- (Biotechnology, Biochemistry: Rs120/-): we are been charged this amount but the concerned authority doesn't seems to have proper first aid kit and the basic first aid requirement. We have one of our friend who got injured during college nours and when he asked for the proper first aid kit he was just given cotton, while the other requirement such as Dettol, scissor, dressing gauze were missing.
- 4. Lab practical fee Rs.880/ (chemistry, physics, zoology, geology)-: we pay this amount in the name of lab practical fee which is more than enough to maintain the lab since it is Rs.880/-per student. But we don't understand why we were charged Rs.95/- from each student at the end of the year even though the student had no breakage charges registered against him/her. when asked to the concerned authority they said it was for the maintenance of the lab. So are we suppose to pay twice in the name of lab fee? Please give a proper clarification.
- 5. Gymkhana fee RS.420/- (Biotechnology: Rs400/-): we are been charged this amount as the gymkhana fee but till today we have never entered this gym. we assure you that half of the students have not seen the gym's interior part and if it is charged for the maintenance, then you'll should charge it from the people who use it and not from the students, who neither use it nor wish to use it. Even after paying Rs.11500/- as the student service we are not given proper facilities. There is no purified water drinking facility, which is mandatory in the college premises as all cannot afford to buy mineral water from the canteen. Taps and door's in the toilets need some maintenance from long time. There is no proper hygiene maintained in the canteen, dog just enter the canteen and sit inside. We have seen dogs in the quadrangle, same place which we use during free time, is this the hygiene college is maintaining? If we sit on the compound of the G-block we are told to get up and move, are we not part of this college why cant we sit there? A/C are there in class but they aren't working still we manage, but just keep a check on the fans atleast either they don't work or make noise and only few of them function. Few projectors are not functioning due to which we have to shift classes when we need them. Website is the another issue which we would like to bring to your notice we are told to check the attendance and many updates on website but the server is always down and are not able to access. Even after paying such a huge amount we lack the basic facilities. So we would like to request the concerned authority to kindly give the proper clarification on the above mentioned issues. So we request you to not give the example saying that it is package for which we have to pay as a whole. Since we ourselves do not known what the package consist of and what are we charged for. Hopefully we will get reply for all our questions mentioned above as soon as possible.

#### Respected Sir,

This has Reference to your letter dated 16.08.2019 seeking comments on the letter dated 15/07/2019 of Miss Rhea Rodrigues.

At the outset we would like to submit that the allegation made by Ms. Rhea Rodrigues that she has been harassed and humiliated by some of the teachers of the English Department is false, baseless and made with malafide intention.

It is submitted that the College has constituted grievance Committee to address the grievances of the students and staff members. The grievances of Ms. Rhea Rodrigues were considered by the said Grievance Committee and after due enquiry the Committee found that the allegations and complaint of Ms. Rhea Rodrigues is false and frivolous.

Without prejudice to above we submit our comments on the Complaint filed by Ms. Rhea Rodrigues dated 15.07.2019 as under:

The allegations, made by Miss Rhea Rodrigues that she has been mentally harassed and humiliated by some of the teachers of the English Department are false, baseless and fabricated as she failed in semester IV in 'Literary Criticism' and in semester VI in 'Contemporary Literary Theory'. On the contrary Miss Rhea Rodrigues and her father have continuously interfered in the working of the English Department. In fact the department has definitely gone an extra step towards extending help to Ms Rhea as is so evident in the discussions with the Department faculty, conversation with father etc.'

As regards the contention of Miss Rhea Rodrigues that 'In spite of answering my sixth semester examination, I have been marked absent in the sixth semester mark list for the term paper entitled 'Contemporary Literary Theory.' It is true that she was allowed to answer the sixth semester examination in bonafide belief that she meets all the required conditions to appear for examination. However it was found that her attendance was much below the required minimum attendance required to answer the examination. Most importantly, she remained absent for the mandatory components of the paper titled 'Contemporary Literary Theory' namely, CA I and Semester End Exam Part 2 which makes her ineligible to answer the semester end examination.

As regards the contention of Miss Rhea Rodrigues that she has secured 29.5 marks out of a total of 40 marks for the CA component (she attempted only TWO of the mandatory THREE) and secured 4.5 marks out of 30 marks in the final written exam, it is hereby clarified that Miss Rhea Rodrigues is ineligible to obtain a final score for the CA component on the grounds that she has not attempted the mandatory assessments. The final score in the CA component out of a maximum of 40 was calculated on the basis of the average of the marks obtained in the THREE mandatory CAs.

As regards the contention of Miss Rhea Rodrigues that she has not been allowed to submit her 30 marks assignment in the same paper by Ms Rajashree Desai citing low attendance as the reason, it is submitted that Miss Rhea Rodrigues was allowed to submit 30 marks Semester End Exam Part 2 component but she did not approach the concerned teacher for the allotment of assignment topic. It is mandatory for the students to approach the teacher for the allotment of their assignment topics. It is evident from the letter written by Miss Rhea Rodrigues to the Principal of our College that she did not approach the teacher.

It is hereby submitted that she is trying to cover up the fact that she did not answer the mandatory component (Part II totalling 30 marks) of the Semester End Examination under the false pretext that the teacher refused to allow her to answer her examination owing to her low attendance. This is in spite of her being allowed to answer the Semester End Examination (Part I) even though she had previously failed to submit the assignment that was mandatory. Attendance sheet of Semester End Exam Part I is attached herewith as Annexure-I.

As regards the contention of Miss Rhea Rodrigues that she has scored low marks as one of the teachers Ms Rajashree Desai teaching the paper warned her not to take the paper at the beginning of the sixth semester and humiliated her on several occasions in the class, it is submitted that it is the practice in the College that the concerned teachers counsel the students regarding the selection of elective papers at the beginning of each semester. As a teacher of the elective paper "Contemporary Literary theory" Ms Rajashree Desai guided/counselled students to offer another elective paper, based on their performance in the precursor paper title 'Literary Criticism' taught in the 4th semester. It appears that Miss Rhea Rodrigues has attempted to intentionally misinterpret the guidance/counselling as 'warning'. It is not true that Ms Rajashree Desai humiliated Miss Rhea Rodrigues in the class.

It may be noted that Miss Rhea Rodrigues has clearly admitted that she has scored low marks in the components that she answered in the sixth semester paper titled 'Contemporary Literary theory' as she remained absent for lectures without paying any heed to the recommendations put forward by the English Department during 2018-19 but she chose to follow her whims and fancies. Recommendations and Apprehensions of the English Department is attached herewith as Annexure-II.

As regards the contention of Miss Rhea Rodrigues that Fearing that Ms Rajashree Desai will not allow her to answer her CA 1 and allot topic/s for assignment based submission in the said paper, a request letter was sent by her to me to grant her permission for the same, it is submitted that it is clear from the above statement that Miss Rhea Rodrigues has been prompted by false prejudiced assumptions and she has tried to go beyond the prescribed rules seeking special permission which was not considered as it will give wrong precedents.

As regards the contention of Miss Rhea Rodrigues that Ms. Rajashree Desai humiliated her on several occasions, it is submitted the contention is false and concocted. It is clear from the fact that Miss Rhea Rodrigues attended Ms Rajashree Desai's lectures in Core Paper titled Nineteenth Century English Literature without any inhibition. She also attended Remedial classes conducted by Ms Rajashree Desai in 'Literary Criticism' (Semester IV) for students who had failed in the paper. She also attended preparatory classes for answering Project viva conducted by Mrs Rajashree. Attendance sheet of Core Paper titled Twentieth Century English Literature is attached herewith as Annexure-III. Attendance sheet of Remedial classes conducted in 'Literary Criticism' (Semester IV) is attached herewith as Annexure-I is attached herewith as Annexure-IV. Attendance sheet of preparatory classes for answering Project viva is attached herewith as Annexure-V.

As regards the contention of Miss Rhea Rodrigues that Ms Rajashree Desai insisted that in the event if Miss Rhea Rodrigues opt for her paper Miss Rhea Rodrigues had to give a written undertaking signed by her father that Ms Rajashree Desai would not be responsible if Miss Rhea Rodrigues failed in the said paper and called Miss Rhea Rodrigues a weak student, it is submitted that Ms Rajashree Desai neither insisted on an undertaking from Miss Rhea Rodrigues's father for the elective paper 'Contemporary Literary theory' nor Ms Rajashree Desai called Miss Rhea Rodrigues a weak student. It is evident from the fact that Miss Rhea Rodrigues continued to be a student of the paper titled Contemporary Literary Theory (sixth semester), in 2018-19

It is very clear that Miss Rhea Rodrigues is making false allegations with ulterior motive.

As regards the contention of Miss Rhea Rodrigues that the syllabus of the fourth semester the paper titled 'Literary Criticism' taught by Ms Rajashree Desai and Ms Gargi was not completed and the examination in the said paper contained only 50% of taught syllabus, because of which she had to repeat the paper, it is submitted that the said allegation is false as the syllabus of the paper titled 'Literary Criticism' taught in 4th semester (S Y B A) during the year 2017-18 was completed and the allegation made by Miss Rhea Rodrigues in this respect is not correct. It is pertinent to note that Miss Rhea Rodrigues is the only student to make false allegation against the teacher. In Fact, Ms Rajashree Desai has conducted 27 lectures out of 30 lectures allotted to her in the said paper. Attendance sheet of Literary Criticism 2017-18 is attached herewith as Annexure-VI.

As regards the contention of Miss Rhea Rodrigues that When complained to me, the said teacher Ms Rajashree Desai justified that she had given audio notes before the examination and the audio notes were given just before five days of examination, when there is no mention of giving any audio notes in the syllabus, it is submitted that the College encourages the use of technology in teaching learning methodology. The concerned teacher uploads audio notes regularly from time to time after delivering lectures on difficult topics. These specially tailored audio notes were specially prepared by the teacher and not down loaded from internet for the benefit of the students. These audio notes were only supplements to the lectures conducted in the regular classes. The supplementary study material, which includes audio notes, was uploaded on different dates. It appears that Miss Rhea Rodrigues is unaware of the fact that syllabus does not mention the teaching-learning methodology.

Miss Rhea Rodrigues and other students who remained absent for CA I were given a repeat CA on 9<sup>th</sup> April, 2019. Notice on the College website regarding Retest is attached herewith as Annexure-VII.

In view of the above submission it is clear that Miss Rhea Rodrigues has made false and baseless allegations against the teachers of English Department only because she was not able to clear the papers titled 'Literary Criticism' (4th semester) and 'Contemporary Literary Theory' (6th semester). It appears that Ms Rhea Rodrigues wants to blame the teachers for her own failure. It is pertinent to note that Ms Rajashree Desai has been teaching English for the last 34 years and there has been no grievance/complaint from any student except Miss Rhea Rodrigues about her teaching during the last 34 years.

From the above it is clear that the allegation of Ms Rhea Rodrigues that she is harassed and humiliated is false, frivolous and baseless.

In view of above we request your good self to reject the allegations and false complaints made by Miss Rhea Rodrigues against Ms Rajashree Desai and close the matter.

I am to inform you that I am a student of TYBA (English) (2018-19) studying in Parvatibai Chowgule College, Margao.

I am compelled to write this letter to you as I have been mentally harassed and humiliated by some of the teachers of the English department. In spite of answering my sixth semester examination, I have been marked absent in the sixth semester mark list for the term paper entitled "Contemporary Literary Theory". I have secured 29.5 marks out of a total of 40 marks for the three CA's (of which I could answer two CA's as the paper was shared by two teachers) and secured 4.5 marks out of 30 marks in the final written examination. I have not been allowed to submit my 30 marks assignment in the same paper by Ms. Rajashree Desai citing low attendance as the reason. It's a fact that I have scored low marks as one of the teachers Ms. Rajashree Desai teaching the paper warned me not to take the paper at the beginning of the sixth semester and humiliated me on several occasions in the class. She insisted that in the event if ! opt for her paper, I had to give a written undertaking signed by my father that Ms. Rajashree Desai would not be responsible if I failed in the said paper. She also called me a weak student. However, it is observed that my classmates with poor attendance have been allowed to answer the examinations. Ms. Rajashree Desai harassment and humiliating behavior in the class compelled me not to attend her classes and this was agreed upon by the Principal and the Head of the department Ms. Sonia Fernandes. The department also informed that I could study the portion taught by Ms. Rajashree Desai on my own. 

The said student Mr. Kuldeep Dasharath Lotulkar had enrolled in our college in June 2016 and has been allotted Roll No. SU160250. The performance of the said student has been very poor till date.

Illustrated below is the semester-wise performance of the student till date which reveals that the student has completed only 34 credits out of the 76 credits he was expected to complete till the end of semester IV. This defies his claim of his years being wasted by the Chemistry department/College.

T	10 (2 attempts)	16
ĪT	6 (2 attempts)	20

Further, inspite of being provided with more opportunities to reappear at each of the subsequent Odd and Even semesters was unable to earn the requisite number of credits because of his continued poor performance. It is to be noted that despite his poor results, he made no efforts to maintain regular attendance at lectures for reasons best known to him.

The Department of Chemistry and the college authorities apprised his parents of his poor attendance and results, but there was no improvement found in the attendance of the student. He has a cumulative attendance of 34.16 % for semester V of the academic year 2018-2019.

As a class policy, at the beginning of this semester in June 2018 itself all the students of the department were notified by the Head, Department of Chemistry to maintain a minimum attendance of 75% to be eligible to answer semester end examination.

It may also be noted that his allegations regarding the exam fee and college looting money from the students on the pretext of repeat examinations are totally baseless. 
