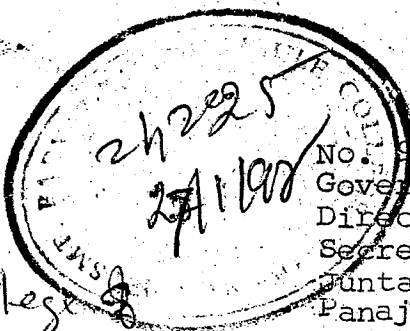

C I R C U L A R

Merit Scholarship in Government and Aided Colleges in Goa  
(excluding Colleges under A.I.C.T.E.)

The Government is pleased to issue the following guidelines for operating the scheme of Merit Scholarships in each Government as well as Non-Government Aided College:-

I. Objectives

Objectives of the scheme of Merit Scholarships are to:

1. Reward meritorious students and
2. Provide incentive to the students to work hard and excel in examinations.

II. Rules

The Rules governing the award of merit scholarships will be as follows:-

1. (a) Merit Scholarships for the I Term of the academic year will be awarded on the basis of marks of the previous year end examination.

(b) Merit scholarships for the II Term will be awarded on the basis of the I Term end examination.

2. The first 3 students in a class (not division) for each academic discipline shall be awarded the first, second and third merit scholarship, provided they obtain at least 60% marks in the examination mentioned in Rule 1.

3. In case more than one student scores equal number of marks and thereby qualifies for the first or second or third merit scholarship, all such students will be awarded the whole scholarship without dividing it.

4. (a) The per term amount of scholarship for the merit scholar at number one will be equal to 50% of the annual tuition fee payable by the scholar.

(b) The per term amount of scholarship for the merit scholar at number 2 will be less by 10% of the scholarship payable to the scholar at number 1.

(c) The per term amount of scholarship for the merit scholar at number 3 will be less by 20% of the scholarship payable to the scholar at number 1.

5. The merit scholarships will be paid to the scholars before the end of each term.
6. If for any reason any college is unable to conduct the first terminal examination, then the scholarship for the II Term shall be awarded to those scholars who were awarded the I Term scholarship.
7. Merit Scholarships shall be given provided there is minimum enrolment of 50 students per class for each academic discipline.
8. The selected students shall be eligible for merit scholarship even if the students are in receipt of scholarships from some other source.
9. Merit Scholarship Scheme shall be implemented in all Colleges (excluding Colleges under AICTE) from the academic year 1998 - 99.
10. The Principal of the College will be competent to sanction scholarships under this scheme.

### III. Funding.

This scheme of merit scholarships will be an admissible item of expenditure in the pattern of assistance approved for all aided Colleges in Goa (excluding Colleges under A.I.C.T.E.).

In respect of Government Colleges, merit scholarships shall be provided from the normal budget of the college.

For holding expenditure on Merit Scholarship admissible under Grants \* aided Colleges should give information in enclosed proforma at the end of each academic year starting from the year 1998-99 onwards.

**Sub: "Merit Based Award and recognition of High Performance in the Board Exams of SSC and HSSC in the State of Goa" for Students belonging to SCs Community - Year 2018 -19.**

It is informed to all the Heads of the Educational Institutions that, applications of students belonging to Scheduled Castes Communities in case of above mentioned scheme may be obtained. A list of students accompanied with duly filled Application Form and copies of requisite documents such as Caste Certificate, Educational Certificate(s), Income certificate, Birth Certificate/proof as Goan Origin, Bank Account of student, Residence Certificate, Aadhar Card and Pre-Receipt duly signed by the student shall be submitted to this Directorate along with the details of the students given in the enclosed proforma (Annexure "A") in the form of **Hard copy** as well as **Soft copy** compulsorily failing which applications will not be entertained. The Applications should reach this Directorate on or before **31<sup>st</sup> August 2019** positively duly completed in all respect and supported with all the documents prescribed under the scheme. **Incomplete applications & without soft copy will not be entertained.**

**Eligibility Criteria:**

The following is the eligibility criteria for the Scheduled Caste students' who has passed X<sup>th</sup> & XII<sup>th</sup> March 2019 Exam:

- Students securing marks in the range (between 50% to 59.99%) will be given a financial award of Rs.5000/-.
- Students securing marks in the range (between 60% to 69.99%) will be given a financial award of Rs.8000/-.
- Students securing marks in the range (between 70% to 74.99%) will be given a financial award of Rs.10,000/-.
- Students securing 75% marks and above will be given a financial award of Rs.15000/-.

Income limit for above is less than Rs.2.00 lakh.

Further, Government of Goa will felicitate the students of SCs Communities in public function in recognition of their high performance in the SSC and HSSC Exams respectively. Under the scheme amongst the SC students, First Five Rank Holders of SSC, First Five Rank Holders of HSSC Board Exams (separately for all the Streams of Science, Commerce, Arts and Vocational) will be felicitated. A Certificate of Appreciation will be given at the time of felicitation and a financial award of Rs.20,000/- will be transferred electronically in the Bank Account of the Rank Holder Student. There are no restrictions on the basis of income ceiling.

**“SCHEME FOR PROMOTION OF SCIENCE EDUCATION”**

**OBJECTIVE:-**

In recent years the larger trend is to join Technical Courses which are market driven offering better employment opportunities, quick money and comfort level. In the process pure Sciences suffer. This will have an adverse effect on supply of quality Science Teachers at School, Higher Secondary and Collegiate Education. It will also have an adverse impact on Research and Development in Science. The Scheme for promotion of Science Education therefore has been basically designed with the intention to promote General Degree Education in pure Sciences so that quality manpower to the educational institutions and scientific laboratories is assured.

**COMPONENTS OF THE SCHEME.**

The Scheme shall have following components:-

**A) CATCH THEM YOUNG**

Under this component every student scoring 75% and above marks at Std. XIIth examination and seeking admission for B.Sc. Courses (grant-in-aid as well as Self-Financing) shall receive a scholarship of Rs. 2,000 per month for maximum of thirty months till he completes his course. In addition he/she shall also be provided with a book/equipment grant to a maximum of Rs.5,000/- per year subject to production of fee receipt and relevant expenditure certificates.

For renewal of the scholarship, a student should secure minimum of 60% at First Year/Second Year B.Sc. Course. The students should have passed their exams in one and same sitting.

**Documents required:**

1. Proof of residence (“In order to establish residence eligibility the applicant required to attach previous school certificates where he studies in Goa continuously for a period of 10 years. In case there is any break in study he is required to produce residence certificate from the Mamlatdar of the break period”). The proof of residence shall be submitted only for the fresh application.

2. Marksheet of qualifying examination i.e. Std. XII<sup>th</sup> Science/F.Y.B.Sc./S.Y.B.Sc. as the case may be.
3. Mandate Form.
4. Proof of purchase of books & equipments, etc.

## **B) SUPPORT FOR PATENTS**

Any student or a teacher who files a patent shall be entitled to receive a grant of Rs. 10,000/-. Further, if this patent is achieved/granted he/she shall be entitled to receive Rs. 40,000/-. If any of these patents are converted into commercial ventures, an amount of Rs. 1.00 lakhs shall be given as an incentive.

In order to receive this benefit the applicant shall be required to produce valid supporting documents in order to consider his/her case.

## **C) SUPPORT FOR EXHIBITION OF RESEARCH BASED PROJECTS**

Any recognized institution which plans an all Goa Exhibition of research based projects shall be entitled to receive a maximum grant of Rs. 1.00 lakhs towards prizes and organization of exhibition. In any given year, two such exhibitions shall be sanctioned. The institution planning to hold such an exhibition shall apply to the Directorate of Higher Education latest by 15<sup>th</sup> of July every year.

## **D) SUPPORT FOR PROJECT PROPOSALS.**

Any College Teacher who submits a research project related to Science and Technology as applicable to Goa shall be eligible to receive grants under this scheme. The following conditions shall have to be met.

- 1) The research project should be in the area of Science and Technology as applicable to Goa.
- 2) It should be useful to the Economic Development and Welfare of the people of Goa.
- 3) The Project should be a fresh project and should not have availed any assistance from the State Government, Government of India or All India Bodies like UGC, AICTE, DST, etc.

- 4) Every Teacher who submits the project should have a minimum of Ph.D qualification in the relevant area.
- 5) Only full time, regular, permanent teachers shall be eligible to submit the project.
- 6) The project should be completed over a period of maximum two years.

The grants shall be released in phased manner as decided by the Directorate of Higher Education. At the end of the project the concerned teacher shall have to submit audited statement of accounts which shall be duly certified by the Head of the Institution. The maximum amount of Research Grant available under this scheme shall be Rs. 5.00 lakhs.

The scholarships under Component 'A' shall be sanctioned at the level of Directorate of Higher Education based on recommendation from the College Principal.

The Grants under the Components 'B', 'C' and 'D' of the Scheme mentioned above, shall be approved by an Evaluation Committee consisting of the following:-





**Sub: “Post Matric Scholarship”, “Gagan Bharari Shiksha Yojana” and  
“Merit Based Award” to ST Students.**

The Directorate of Tribal Welfare is implementing the Schemes namely:

- The Scheme of “Post Matric Scholarship” to the students belonging to Scheduled Tribes for studies in India.
- Financial Assistance to ST students under “Gagan Bharari Shiksha Yojana”
- “Merit Based Award” and recognition of high performance in the Board Exams of SSC and HSSC in the State of Goa

**The Scheme of “Post Matric Scholarship” to the students belonging to Scheduled Tribes for studies in India.**

The Scholarship are available for studies in India only and are awarded by the State Government to which the applicant actually belongs i.e where permanently settled. The Scholarships are available for the study of all recognized Post- Matriculation or post-Secondary courses in **Government recognized institutions** except certain identified training courses like Aircraft Maintenance Engineer’s Courses, Private Pilot License courses etc. Scholarships are available to the students whose parents/guardians income from all sources does not exceed **Rs. 2,50,000/- (Rupees Two Lakh Fifty Thousand) per annum.**

**Financial Assistance to ST students under “Gagan Bharari Shiksha Yojana”**

To provide additional financial assistance to the Scheduled Tribe students as the maintenance allowance given under the Post Matric Scholarship is inadequate to meet the expenses on food and travel. ST students must have availed or eligible for centrally Sponsored Post Matric Scholarship during the current academic year. The Scheduled Tribe students whose Annual Family Income is less than **Rs. 3,00,000/- (Rupees Three Lakh) per annum** is eligible for “Gagan Bharari Shiksha Yojana”.



**“Merit Based Award” and recognition of high performance in the Board Exams of SSC and HSSC in the State of Goa**

Merit Based Award for ST students whose Annual Family Income is less than **Rs. 5,00,000/- (Rupees Five Lakhs) per annum** having secured the requisite bench mark percentage of 50% and above.

Fresh Students are requested to submit application in prescribed form of “Post Matric Scholarship Scheme” and “Gagan Bharari Shiksha Yojana”/ “Merit Based Award” through their Colleges/institutions i.e. those who are enrolled for the first time in Colleges/institutions. The following documents are required to be submitted.

1. Passport Size Photograph.
2. Attested copies of Mark sheet/Passing Certificate.
3. Attested copy of Income Certificate issued by competent authority for the year 2017-18.
4. Attested copy of Scheduled Tribe Certificate issued by competent authority.
5. Attested copies of Fees payment receipts.
6. Copy of Bank Pass Book.
7. Attested copy of Aadhaar Card along with Consent form

No separate application for renewal of “Post Matric Scholarship Scheme” and “Gagan Bharari Shiksha Yojana”/”Merit Based Award” is required, but the students who have failed in the same class will not be entitled to fill the form of above Scholarships.

Therefore all the Head of Institutions are requested to verify the details and submit the list of ST students who have passed and promoted to next class as **renewal list**. The list of such students should be submitted to this office along with the following documents:-

1. Attested copy of Mark sheet for the Academic year 2018-19.
2. Attested copies of Fees payment receipts.
3. Copy of Aadhar Card along with Consent form if not submitted at the time of submission of Fresh Application form.

Therefore all the Head of Institutions are requested to submit the fresh applications as well as **renewal list** of students along with the above mentioned documents.

Enclosed Proforma of Annexure of Renewal applications and Fresh applications should be submitted in soft copy (CD) in Excel Sheet only. Incomplete data in CD will not be accepted and the same will be retuned along with the application forms to the Institution

All the Applications for Academic year 2018-19, of the professional colleges/Courses like Medical / Engineering / Architecture /Pharmacy/ Nursing/Law/BED/DED/MA, M.Com, MSC, MBA, PHD & other such Post Graduate Courses /Polytechnic/ITI should be received by this Directorate on or before 1<sup>st</sup> October, 2018.

All other applications for Academic year 2018-19, of the colleges/Courses except as mentioned above should be received by this Directorate on or before 31st July, 2018.
